ANNUAL PARISH MEETING MINUTES

February 5, 2017

Call to Order: Warden Connie Harasymiw officially called the meeting to order at 10:38 AM.

Opening Prayer: Warden Rebecca Scruton opened the meeting with prayer.

Establish a Quorum: Denise Paternostro determined that the 46 people present at the Annual Meeting satisfied the requirement for a quorum.

Adoption of Minutes of the Annual Meeting February 7, 2016: Following no suggestions or changes, it was moved and seconded that the minutes of the 2016 Annual Meeting be approved as provided in the Annual Report. The motion carried.

Correspondence (if any): - none

Comments by the Wardens: Connie and Rebecca have served as co-wardens during this past year and, therefore, decided to present a joint report.

- The two goals for 2016 were to build a strong, spiritual community and to determine our
 financial viability as we seek to move forward as a parish. We have made good progress on these
 goals even though the past year was filled with upheaval and unexpected changes, including the
 resignation of our Priest in Charge, Lois Keen, in August and the deaths of fifteen beloved
 members and friends.
- We have been conscious of the Holy Spirit's guidance and love, bringing new people into our family and a steady supply of clergy to lead our worship services and encourage our hope for the future of our parish. Sunday attendance has increased significantly; the weekly Bible Study group is thriving; we continue to be very active in our outreach work; and more people have been stepping up to help accomplish the work of the parish.
- We have a sustainable budget for the coming year with enough funds to call a part time priest at the start of the summer. The Wardens have begun to meet with The Rt. Rev Laura Ahrens and Canon for Mission, Lee Ann Tolzmann to discern the next steps in Trinity's future. We are viewed as a viable parish by the diocese.
- We are developing a connection with St. Paul's Lutheran Church in Wethersfield and plan to share worship services during Lent.
- We are exploring opportunities to rent our space to organizations in our community.
- We are asked to be faithful in our listening to God and to each other and, above all, to be people of prayer, seeking and trusting in God's presence and call for us at Trinity.

Treasurers' Reports: Rob Heath presented the 2016 Financial report.

- Income was less than budget by \$9,000. Pledges were under by \$8,400 and non-pledge income by \$2,100. This was mostly due to deaths and people relocating.
- Expenses were under budget by \$23,900 because we had no rector for several months and building expenses and utilities were less than expected.
- 2016 was a deficit budget; actual expenses exceeded actual income by \$46,000. The withdrawal of \$61,200 from our investment account covered the difference.
- After a short discussion, it was moved and seconded that the 2016 Financial Report be accepted. The motion carried.

2016 Budget: Rob Heath presented the 2016 Budget as approved by Vestry. After a short discussion, it was moved and seconded that the 2016 Budget be accepted. The motion carried.

Report of the Nominating Committee for Vestry: Denise Paternostro presented the slate of officers for 2017. Connie Harasymiw and Rebecca Scruton will continue to serve as Wardens, Carol Jones as Parish Clerk, and Rob Heath as Treasurer. Kathy Cole was nominated as Co-Treasurer; Donna Brown, Ray Colburn and Rose Riley were nominated to serve on Vestry for two-year terms. Also nominated were: Vickie Crafa, Denise Paternostro and Ed Zagorski for the 2016 Nominating Committee; Rose Riley and Kathy Cole for Convention Delegates. No Alternate Convention Delegates were nominated. Denise thanked the 2016 Nominating Committee for their diligent work.

Elections: It was moved and seconded to accept the Nominating Committee Report. The motion carried.

Acceptance of All Printed Reports: A motion was made and seconded to accept all the printed reports. The motion passed. Connie expressed thanks to all. Joan Joseph expressed thanks to Connie and Rebecca for their tireless work as wardens and everyone enjoyed cake in their honor. Rebecca expressed thanks to Arline Hallisey for her many years of service as Directress of the Altar Guild and presented her with a commemorative plaque and roses.

Other Business

- Connie announced that a new sexton has been hired, Nick Tracano, who will be working 12 hours per week.
- Jessie Karpf, deacon in training, thanked Trinity for financial support and the wonderful experience of being a part of our community.

Motion to Adjourn: A motion to adjourn was made and seconded at 11:32PM. The motion passed.

Closing Prayer: Rebecca adjourned the meeting with a closing prayer.

WARDENS' REPORT

Dear and Gracious God,

"...... please send us the people we need in order to become the church You want us to be, and please send us the people who need us in order to become the people You want them to be. Help us to respond with love to those You send, making room for them at our table and in our hearts. We ask this in the name of Jesus, who met people where they were, loved and cared for them, and invited them into a real relationship with You. Amen"

Along with praying for each of our parish family by name, we have prayed this prayer faithfully and constantly throughout this past year. In looking back over the last 12 months we see how the Lord has answered us with his ever-present abundance. He has led us up the road of becoming a "God Guided, Lay Led Congregation" AND we have even had the opportunity to dance along the way.

We have been truly blessed with a consistent rota of supply clergy for more than a year, who share such different, but always scripture based, sermons with us. We have come to appreciate their dedication to Trinity. They have supported us and ministered to us in the name of the Lord with love and faithfulness. We appreciate their conversations during coffee hours and through them we have learned what love for the Lord and for each other really looks like and for this we are eternally grateful.

We received from the Diocese the name of a possible missional priest. We, the vestry, had the awesome experience of how God works through a prayerful, honest, Christ centered discernment process. Although both the priest and we had a mutual affinity and desire to come together as priest and people, the mutual discernment process revealed that he wasn't able to say yes to our call. In this we experienced our disappointment in the outcome, while at the same time we 'knew' God's leading and presence. This helped us build and establish God's faithfulness and presence in all aspects of our life here at Trinity.

Our Bible Study group on Thursday mornings has added several new members and consistently totals 12 to 15 in attendance. Adult Formation is in a re-formation season, with a new committee working on ways to help us deepen our spiritual growth in all seasons of our lives.

Our outreach efforts continue to be strong. We are able to support St. Vincent's School (for the disabled and blind) Haiti and Holy Trinity School, Haiti (started by the Anglican Order of the Sisters of St. Margaret) and South Park Inn. Our partnership with the Church of the Good Shepherd, Hartford terminated mid-year by mutual agreement and our efforts now will lead us to a more locally and regionally centered outreach in Wethersfield. As a recipient of our Outreach efforts, we have taken on Kateri Medical Mission, which helps to build and equip medical clinics in Nigeria.

We have entered into an agreement with the Board of Education of the Town of Wethersfield to rent space for a Family Literacy Program. This is a Federal grant funded program to provide ESL services to mothers and at the same time provide quality child care and ESL services to preschool children. There are 9 mothers, 12 children with 7 'first' languages represented. It's a joy to hear the voices of energy and life emanating from our lower level. It is also a privilege to have our facility be used for such a wonderful effort. We, through this endeavor, have truly been given the opportunity to be the arms of God to those in need.

As a result of God's grace, our sense of community and our caring for each other as well as our spiritual growth has visibly deepened allowing us to come together in agreement and to make changes as to how we worship at Trinity. We now worship at one service on Sunday mornings at nine o'clock. This brings all of us together at one time and in one space. We are not all of one heart and mind regarding this change, yet, we are of one heart and mind in our desire to strive for the good of the whole even when this means change that is not our personal preferred form of worship. We are also exhibiting a desire to 'listen to the Holy Spirit', and to follow in the way God wants us to move, for God's sake and for the kingdom of God. We are working hard at living out "thy kingdom come, thy will be done".

In this new experience, we continue to be flexible with joy and energy as we had the serendipitous movement from worshiping in the Sanctuary to worshiping in the Parish Hall. We discovered that with the lack of heat in the Sanctuary, we were blessed to have a warm alternative for worship. Warmth of environment and community were palpable and very special. We learned that community with each other and with our Lord deepens and develops when we are challenged and drawn into new paradigms. We learned that God truly walked before us, preparing the way.

Since our December beginning of our one service, our Worship Committee has been meeting and suggesting ways to combine Rite One and Rite Two. This has enabled us all to experience a greater breadth of worship as provided by our Prayer Book. We as a community have been able to walk and worship together into a new experience. As promised when we began this new season at Trinity, a task force has been hard at work developing a time when we will have open conversation and sharing about this change. You will be hearing more of this in the days to come.

We joined with St. Paul's Lutheran Church for a shared Lenten program and combined Holy Week Services. This was so positive for both congregations that we will have a theme and variation of this experience this Lent.

Over this past year, more lay leadership has been solidified and developed. We are starting to develop systems that help us share together in God's mission in and through Trinity. This is seen in our Property Committee (a special thank you to Warren Blessing, Ray Colburn and Connie Harasymiw), Worship Committee, Outreach Committee, Christian Formation Committee. Our strengthened lay leadership has also provided deeply thought provoking and soul-searching reflections for both morning prayer, the Belfry and for the supply clergy when asked.

Our hospitality endeavors continue to need point people for a consistent, supportive presence. However, more and more folk have been signing up for our coffee hour which has become a wonderfully energetic time of connecting, welcoming and sharing. We are ever and forever grateful for Sal Basile's gracious gifting of his performing for us, enabling us wonderful social times and an added source of income for Outreach.

We are deeply grateful for God's answer to our parish prayer to '...bring us the people we need in order that we can become the church You want us to be'. A number of you here have come over the last 12-15 months, and you have stayed!! Not only have you stayed, but you have joined in, you are truly helping us to become the church God wants us to be...You, each of you has blessed us be being part of our journey and letting us be part of your journey.

Thank you, thank you.

We now want to say how grateful we are to have had the opportunity to be your co-wardens for these past two years. We are humbled by your support, your trust, your vulnerability and your willingness to walk into so many areas of 'unknown'. This has been a truly unique two years. We are constantly walking into the 'unknown'. We are going where few have gone and on a journey without roadmaps. We are a new church in the making and you have honored us by trusting us, by walking with us and most of all praying for us and our community.

We have not done this alone. Many here have 'been there' for us and our community, some in quiet ways, behind the scenes and others in obvious leadership, 'upfront' capacities.

We know that as we move forward your new wardens and vestry will do all in their power to love and serve you and to love and serve the Lord.

We must all be here to support them and to pray daily for them... for they are here to be purveyors of what God desires and to help us to continue to move in that direction.

We would be remiss if we did not share one more "thank you". We want to thank publicly and from the depths of our hearts, our husbands (Raymond and Gordon). They have been our rocks, our support, our sounding boards, our cheer leaders, 'voice of reason', cooks and bottle washers, editors. They have held us metaphorically and literally. Without them, their thoughts prayers and presence, we would not have been able to be the best that we could be... and we thank you.

Above all, we thank God for his very real presence which sustained us, comforted us and informed us, in the many areas of unknown, unexpected, challenging, joy filled, sorrow filled, opportunity ridden aspects of this role.

And now as we look back, we can say with confidence, 'God IS working his purpose out, as year succeeds to year...' and looking forward we can say unequivocally as stated by the apostle Paul in Ephesians, "Glory to God whose power, working in us, can do infinitely more than we can ask or imagine: Glory to him from generation to generation in the Church, and in Christ Jesus for ever and ever. Amen."

Our roles will change, but our love and prayers remain with each one of you as we continue to walk together.

REPORT OF THE TREASURER – 2017

Notes to Financial Statements:

A. Trinity Parish 2017 Budget and Actuals (pg. 10)

Income was more than budget by \$3.4k.

- Pledges were under by \$9.8k, but Non-Pledge was over by \$9.3k.

Expenses were under budget by \$59.5k.

- Compensation was under because no Rector for the year partially offset by an increase in Supply Clergy. Staff worked fewer hours than budgeted.
- Program over: increased Supply Clergy to offset no Rector.
- Church Property under because of reduced utility, insurance, snow removal, and Maint. costs.
- While 2017 was a deficit budget, it turned out actual income exceeded actual expenses by \$1.8k. Withdrawal of \$15,300 from our Investment account will be used for 2018.

B. Designated/Restricted Accounts (pg.11)

The Vestry has defined Designated and Restricted Accounts as follows:

Designated Accounts are those where money was given for a specific purpose and must be used for that purpose.

Restricted Accounts are those where money was given but without a specific purpose.

Vestry approves expenditures.

Some designated accounts, such as the Flower Fund are managed by a group within Trinity who disburse funds from the account as appropriate. Other accounts such as Memorial Fund are used with Vestry approval.

The monies for these accounts may be in the checking account or investment accounts. Monies added to these accounts or disbursed from these accounts are not reflected in the Operating Budget. A total picture of Trinity's accounting must include both operating and designated/restricted fund activities.

C. Budget 2018 (pg. 12)

Expenses were reduced by \$34.2k, and Income was increased by \$2k (\$5.6k from "school") leaving us with a deficit of \$24.6k. Pledge amount was decreased by \$12.4k but non-pledge increased by \$8.7k. Rector compensation reduced by \$24.1k because only covers Supply Clergy and some for Missional Priest (partially offset by decrease in Supply Clergy). Staff reduced by \$4k because fewer hours. Other smaller increases and decreases were scattered in different areas.

Fiscal Year 2017 accounts were processed using Power Church Plus software, a modified accrual accounting system.

Comments on Designated/Restricted Accounts:

Memorial Fund-Restricted additions were for several people, and \$126,216 from Florence Webster Estate. Memorial Fund-Restricted disbursements included money to repair a cross.

Memorial Fund-Designated addition was money transferred to replace money used to pay for the window repair.

Special Gifts disbursements included web support, liturgicals, broken window, and Deacon support and stole. Special Gifts additions included floor cleaning, Christian Formation, and \$1,350 un-restricted.

Sale of Rectory disbursements was \$15,300 for potential shortfall. Since not needed it will be used in 2018.

Stained Glass Windows: \$3,630 transferred to replace \$s used to repair window, and Lexan protective cover.

Received \$543 for Tea during House Tour, and for Bruce's organ concert.

Altar Guild: received \$25 donation, and spent \$60 for plague, and \$1,412 for new linens (mem. gift last year).

Physical Improvements: Received \$5,474 from insurance company for ice damage.

Spent \$2,500 for gutters, \$6,320 for painting, \$3,780 for window repair, \$4,650 for ceiling and tile repair, and \$400 for carpet cleaning

OUTREACH REPORT

Trinity's recorded outreach commitment goes back to the early 1980s when we began supporting Holy Trinity, an Episcopal school in Haiti. In 2003 our Outreach Committee was reorganized to focus on **local, regional, and worldwide organizations.** Many of our outreach projects support the Millennium Development Goals, particularly #1 "Eradicate Extreme Poverty and Hunger" and #2 "Achieve Universal Primary Education." Outreach activities reported for 2017 include projects under the "Outreach Umbrella" in addition to those administered by the Outreach Committee. Trinity also provides access to our building for outside organizations.

South Park Inn, Hartford is an organization that we give to throughout the year as part of our local/regional outreach giving. This organization is focused primarily on the needs of the homeless. We always have bins at the back of the church and in the parish hall to accept donations for South Park, and we run several special drives during the year. In 2017 we did a Lenten giving program as part of our journey to Lent in which we raised awareness of the differing needs of South Park. During November and December, we collected warm outerwear for the homeless in our "Warm Hearts, Warm Hands, Warm Feet" drive. We are looking forward to continuing to grow our relationship with this wonderful organization.

St. Vincent's Center for Handicapped Children, Haiti, after nearly eight years in temporary facilities in Port-au- Prince, Haiti because of the earthquake, moved into their new school at Santo 17, a short drive from the airport. No more steps to climb or broken elevators to work around, the students now have plenty of room to walk, run, wheel, or stroll on some seven acres of level ground and one-story buildings. Enrollment has reached nearly 200 students – 102 deaf, 44 blind, or visually impaired, and most of the remainder with some form of physical disability. The new property is surrounded by a security wall and includes boys' and girls' dormitories, 17 classrooms, a music room/library, administrative offices, common living areas, a chapel, and an infirmary. There is also ample room on the property for future development, including space for gardens and farm animals. There is a new focus between a team of teachers at St. Vincent's and the Education Committee of the Board of Directors to improve instruction at the school and to provide long-term vocational guidance for each student through all grade levels so that when they graduate students will be equipped to contribute to society.

Annual Chili + Rice & Beans Cook-Off continued to "take on a life of its own" this year but as a joint endeavor between Trinity and St. James' Episcopal Church in Glastonbury with St. James' hosting. It was a very successful event with good attendance and a large check sent to St. Vincent's Center for Handicapped Children in Haiti. We plan to continue this project with Trinity hosting in 2018.

"Golden Oldies" Concerts presented by Sal Basile in May and November were a big highlight of the Outreach Committee's year. The attendance has grown each time Sal generously gives his time and talent for the benefit of the Outreach Committee with the proceeds divided among the organizations we support. The Bistro-style setting with appetizers, etc. has been well received by our parishioners and the community.

Christ Church Cathedral Dinners, Hartford. Trinity has volunteered to support the homeless at Christ Church Cathedral in Hartford. We provide the food, preparation, and serving of approximately 100 dinners four or five times per year. The food is all donated by our parishioners by providing the food or the monetary gift to purchase the food. We have been delighted this year to have many new

members assist in our endeavors, while many of our existing members continue to assist as well; we have been well supported. This has been a very fulfilling experience personally, and we find the recipients are very thankful of our efforts.

Warren & Lynda Blessing, liaison to Christ Church Cathedral Dinners

Kateri Medical Services, Nigeria. This is the second year Trinity has supported the Kateri Medical Mission led by Fr. Tom Furrer and his team. In July they traveled to Kaduna where they held medical clinics and were able to help thousands of people. They went to Guasau diocese in October where they are building another clinic. The new clinic is located adjacent to the newly built diocesan school called Graceland International School. It is a K-12 grade facility with 300 students, about 10% of whom are Muslim. While in Nigeria, Fr. Tom taught New Testament Greek and preached in several Anglican churches.

Copprome Orphanage, Honduras. 2017 was my 14th year going to Copprome. I always go at least 2 times a year for 10 days each time. Copprome has 40 children ranging in age from 4-20 years old. It is almost equally divided between boys and girls. While there I use the money I raise for food, clothes, day trip to a water park, a morning to the movie theater and various other needs. In the fall I buy a red fruit they love that grows on trees and is only ripe in the fall. I have full use of the kitchen and cook American food for the children almost every day as well as cookies, cakes and brownies. They are also given pizza and birthday parties. Although this fall turned into a somewhat dangerous situation due to political unrest, the children are doing very well and 3 actually graduated high school – a really big deal and accomplishment. Thank you Trinity for your continuous prayers and support of these beautiful children.

Ginger Smith, liaison to Copprome Orphanage

Family Support Center, Church of the Good Shepherd, Hartford. Trinity participated with Church of the Good Shepherd for the first part of 2017 by making and serving soup to an average of 100 people. This was in addition to collecting and distributing clothing to go to people and to helping to distribute food from the Food Share truck. These activities occurred every other Tuesday. Our collaboration came to an end after nine years this past spring by mutual agreement.

Organizations and events also receiving Trinity support were: Teddy Bear & Friends Sunday to benefit the Connecticut Children's Medical Center in Hartford, our Lenten Outreach project which benefitted South Park Inn and the Family Support Center at Church of the Good Shepherd, our Annual Christmas Toy Drive with seven bag of toys going to homeless children currently living at South Park Inn, Episcopal Relief & Development in support of Hurricane Harvey in Texas, AA, Al-Anon, Wethersfield Fuel Bank, World Vision, and our newest project The Wethersfield Food Bank.

The Outreach Committee is grateful to the Vestry for providing 25% of the 2017 Fair proceeds and to all of our parishioners who supported us in so many ways. We feel privileged to participate in being the hands and hearts of Jesus locally, regionally, and worldwide.

It is an ongoing challenge to predict what might be needed next in our aging church. The following is a list of those accomplishments for this year:

- Kitchen refrigerator repaired twice.
- Completed the outdoor Lexan rack to keep snow off the restored Tiffany window that was installed.
- Insurance claim for building damage almost finalized.
- New dishwasher installed in the kitchen.
- Rental and preparation of the church school area to the Wethersfield School for the Family Literacy Program.
- Carpets cleaned in lower School area.
- Repainting of many hallways and rooms completed.
- Wi-Fi system installed in north end of the building.
- Outdoor cleanup sessions occurred 3 times throughout the spring and summer.
- Organ evaluation, tuning and repairs have taken place.
- Documentation of the A/C system and Heating System as to how it is started up and closed down was completed for the seasonal changes. Labeling of valves done to aid in change over.
- Bathroom leaks, toilet seat replacement, and professional cleaning of all seven lavatories was completed.
- Stair Lift Service Agreement put into place.
- Service agreement with Cintas was put into place to service our emergency lighting and fire extinguishers.
- Snow removal contractors were evaluated and a new vendor hired.
- Garage door motor repaired.
- Drains in between buildings in courtyards were cleaned.
- Exterior sign work completed for service changes.

Looking towards next year, we have obtained quotes and are looking at several larger projects such as the parish house ceiling and lighting, repair to office lobby ceiling and lighting and repair of office lighting fixtures.
