

Retreat Terms

Wi2 Co-Lab LLC and Athena Valley of the Sun's *Mind Body, & Spirit Women's Leadership Retreat / Sept 7 - September 10th, 2023*

Terms & Conditions

By signing up and/or registering for this retreat, you voluntarily understand and accept the following terms and conditions as set out below.

Retreat Payments:

All payments are due upon registration - See below for the payment schedule.

Early-Bird Discount

Pay \$2222 upon registration as long as you register by 7/15/2023.

Standard Rate

Pay \$2555 upon registration if between 7/16/23 and 8/23/2023.

Refunds/Cancellation (regardless of the circumstances):

Cancellations that take place by July 23, 2023, 100% of funds paid will be refunded.

Cancellations that take place between July 23rd 2023 - August 23th, 2023, 50% of funds paid will be refunded.

If cancellation takes place after August 23rd, 2023, 0% of the funds are refundable.

The reason for this cancellation policy is because payment and final deposits must be made by the retreat center well in advance of the retreat or event, meaning if the closer we get to the event the more likely that your reservation at the retreat center has already been paid to them.

****Transferring your Registration to a 3rd party:** In the event that you cannot attend the retreat but know of someone who can take your place, you can transfer the full amount of your fees paid to the 3rd party without penalty, on condition that we are notified promptly by both parties of this transaction and the third party completes a registration form, all required paperwork.

General:

- Yoga mats and props will be provided.
- Participants are responsible for providing their own comfortable clothes for your practice.
- All sessions, classes/workshops and 3 meals per day are included in the price but are optional. (One meal on Thursday and Sunday)

- No refunds will be given for missed classes, sessions, meals or other included activities.
- Please let us know of any food allergies/restrictions - if we are not notified we are not responsible to accommodate.
- Meals may be served at designated times so there are no 'make up' meals if a meal time is missed.

USD - The payment must be paid in USD by the participant and received by the facilitator to secure accommodation and retreat spot.

Travel Insurance if applicable:

- We highly urge you to purchase Travel Insurance if you are traveling to Arizona to attend this retreat.
- The organizers, facilitators and/or hosts are not liable for any delay or cost resulting from natural disaster/tragedy, civil unrest, strike, sudden death, serious illness or lost passports.

Transport if applicable:

- Transport to and from the airport is the responsibility of each person as applicable.
