GENERAL CODE OF BEHAVIOUR

As a member of *GA*, a Member Association or an affiliated club or a Parent/Guardian or Volunteer, you must meet the following requirements in regard to your conduct during any activity held or sanctioned by *GA*, a Member Association or an affiliated club and in any role you hold within *GA*, a Member Association or an affiliated club:

- 1. Respect the rights, dignity and worth of others.
- 2. Conduct yourself in line with GA's values.
- 3. Be fair, considerate and honest in all dealing with others.
- 4. Be professional in, and accept responsibility for, your actions.
- 5. Make a commitment to providing quality service.
- 6. Maintain a duty of care to others involved in GA, the Member Associations and the affiliated clubs (where a duty of care applies).
- 7. Be aware of, and maintain an uncompromising adhesion to, GA's standards, rules, regulations and policies including this Policy, regarding appropriate physical contact with children.
- 8. Establish and maintain an environment that is safe for the conduct of activities and for children:
- 9. Listen and respond to the views and concerns of children, particularly if they are telling you that they or another child has been abused and/or are worried about their safety or the safety of others
- 10. Promote the cultural safety, participation and empowerment of Aboriginal children (for example, by never questioning an Aboriginal child's self-identification)
- 11. Promote the cultural safety, participation and empowerment of children with culturally and/or linguistically diverse backgrounds (for example, by having a zero tolerance of discrimination)
- 12. Promote the safety, participation and empowerment of children with a disability (for example, during personal care activities)
- 13. Ensure as far as practicable that adults are not left alone with a child
- 14. Report any child safety concerns or allegations of child abuse and ensure any allegation is reported to the police or child protection agency.
- 15. If an allegation of child abuse is made, ensure as quickly as possible that the child(ren) are safe
- 16. Encourage children to 'have a say' and participate in all relevant organisational activities where possible, especially on issues that are important to them.

- 17. Operate within the rules of the sport including national and international guidelines which govern GA, the Member Associations and the affiliated clubs.
- 18. Do not use your involvement with GA, a Member Association or an affiliated club to promote your own beliefs, behaviours or practices where these are inconsistent with those of GA, a Member Association or an affiliated club.
- 19. Demonstrate a high degree of individual responsibility especially when dealing with persons under 18 years of age, as your words and actions are an example.
- 20. Avoid unaccompanied and unobserved activities with persons under 18 years of age, wherever possible.
- 21. Refrain from any form of harassment of others.
- 22. Refrain from any behaviour that may bring GA, a Member Association or an affiliated club into disrepute.
- 23. Provide a safe environment for the conduct of the activity.
- 24. Show concern and caution towards others who may be sick or injured.
- 25. Be a positive role model.
- 26. Understand the repercussions if you breach, or are aware of any breaches of, this code of behaviour.

Members of GA, including Member Associations, Affiliated Clubs or a person required to comply with the Member Protection Policy, must not:

- 1. Shame, humiliate, oppress, belittle or degrade any person, particularly children;
- 2. Unlawfully discriminate against any child including because of culture, race, ethnicity or disability;
- 3. Engage in open discussions of a mature or adult nature in the presence of children;
- 4. Engage in any activity with a child that is likely to physically or emotionally harm them;
- 5. Initiate unnecessary physical contact with a child, or do things of a personal nature for them that they can do for themselves;
- 6. Be alone with a child unnecessarily and for more than the shortest possible time;
- 7. Develop a "special" relationship with a specific child for their own needs;
- 8. Show favouritism to children through the provision of gifts or inappropriate attention;
- 9. Arrange contact, including online contact, with children outside the organisation's programs or activities;
- 10. Have contact with children under the influence of alcohol or illegal drugs;

- 11. Use inappropriate language in the presence of children;
- 12. Do anything that brings GA, a Member Association or an affiliated club of the sport of gymnastics into disrepute or engage in conduct that is unbecoming;
- 13. Engage in any form of harassment of others; and
- 14. Use their involvement with GA, a Member Association or an affiliated club to promote their own beliefs, behaviours or practices where these are inconsistent with those of GA, a Member Association or an affiliated club.
