Offering day of show entries(if limits have not been reached)! These entries will only be accepted each day between 7-7:30am. Fees will be the same as the late entry fees listed above.

Dogs may enter both the Instinct Test and Novice class in the same trial *until the dog has earned the RATN title and then they cannot enter the Instinct Test*. Move-ups will be accepted from trial to trial. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. Make checks payable to K9OTC. Send entries & fees to the trial secretary. Dogs must have a Barn Hunt registration number to enter.

## EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS. There is NO SMOKING in this facility. Please pick up after your dog and dispose of waste in appropriate containers outside the building. **Our exercise area is across the driveway on the West side of the facility.**

### **RUNNING ORDER:**

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.

The running order and further scheduling details will be emailed to all exhibitors no later than **Monday April 22nd**, after the actual number of entries is known for each class. If you do not receive an email by Monday night, please contact the trail secretary.

### **Height divisions:**

Dogs 13" and under small

Dogs 13.1 to 18" medium

Dogs over 18" large

**AWARDS:** Ribbons will be awarded for first through fourth place in Novice, Open, Senior, and Master classes in each height division. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. A High In Class Award will be offered in Novice, Open, Senior, and Master classes. Title Ribbons will be awarded to all dogs earning a title.

There will be crating space available inside the NOVICE building but please make sure your crate is secure as the dogs may be highly excited.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.
