Covid-19 Obedience/Rally Guidelines

K9 Obedience Training Club is dedicated to the health and safety of all our exhibitors, stewards, and judges. If you have any questions regarding this, please email the trial secretary at pkrauss59@gmail.com or the trial chair at doberman@aol.com.

- Please **DO NOT COME** to our trial if you feel sick, or if you have been exposed to Covid-19 in the last 14 days. **DO NOT COME** if you are concerned about being exposed to the Coronavirus. Please do not enter if you are not willing to follow the rules. We have put together these rules and guidelines based on CDC, Government, and AKC suggestions. Some of these guidelines are subject to change between now and the trial. Read the judging program thoroughly for any updates.

- **Masks** will be required for all exhibitors, stewards and judges. They will be provided if you do not have your own. **No exceptions!** If you won't or can't wear one you will be asked to leave.

- Please look for entrance and exits. They will be marked.

- Please observe 6' social distancing when in line for armbands, ribbons, ring gate, bathrooms, etc.

- We will have multiple bottles of hand sanitizer available for use. However, please wash your hands using soap and water as frequently as possible.

- Avoid touching dogs that are not yours.

- Workers will be disinfecting surfaces around the facility periodically.

- We will have the areas around each ring marked for social distancing.

- Crating... We will accommodate as many dogs as possible to crate inside.

- Exhibitors are to arrive 30 minutes before the start time for their class and should leave after showing their dog.

- Please, no socializing in the building. All socializing should be outside the building.

- Start times for classes will be spaced out to allow exhibitors to leave before more exhibitors come in.

- **Spectators are not permitted.**

Thank you for reading and complying with these rules and guidelines. We hope to make this trial the safest it could be.

Remember to wash your hands frequently. Leave the building as soon as your done showing in order to reduce the number of people inside the building. I know we are all anxious to visit with our friends that we have not seen in a long time. Please keep all the socialization outside of the building and continue to practice social distancing.

RULES & REGULATIONS

ENTRIES CLOSE at the Trial Secretary's address, Wednesday, February 24, 2021 at 6 p.m. Central Time. After which time entries will not be accepted, cancelled, altered or substituted as provided for in Chapter 11, Section 6 of the Dog Show Rules.

Exhibitors please note: A RECORDING FEE and event fee will be required for each dog, and are included in the entry fees as mentioned herein. These fees are to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class, the fees are to be collected on the first entry only at each Obedience Trial. Fees are collected on each Rally entry. All fees are included in the entry fees listed. Rally and Obedience are each separate trials. (American Kennel Club Rule, Chapter 11, Section 2).

MAKE CHECKS and money orders payable to K-9 OTC, Inc. (Returned check fee is \$20.00 and does not constitute a valid entry). **Write class entered on face of check.** No third party checks accepted.

ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS. Photocopies of front and back will only be accepted if legible. **ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURE, FEES, OR BACK OF ENTRY AGREEMENT.** Illegible entries will not be accepted.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Judge or barred from competition by action of the Show Committee. A full refund shall be made for an entered bitch that comes in season after entries close upon presentation of a statement by a licensed veterinarian. Notification must be in the hands of the Trial Secretary by 8:00 a.m. the morning of the show.

SHOW HOURS are 8:00 a.m. to 6:00 p.m. central daylight savings time. Dogs are not required to be at the show until scheduled time of judging. Judges will NOT wait for dogs. Dogs not needed for further judging will be excused.

ALL TROPHIES must be claimed at the trial. Exhibitors must remain for presentation if eligible for special prizes or they will be forfeited.

ALL DOGS MUST BE ON LEASH except when being judged. The owner/handler of each dog is solely responsible for being ready ringside when its class is being judged.

ENTRIES MAY BE DECLINED by K-9 Obedience Training Club of Menomonee Falls, Inc. for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes and no one shall have any claim or recourse against K-9 OTC or any official thereof.

IF BECAUSE OF RIOTS, CIVIL DISTURBANCES, OR OTHER ACTS BEYOND THE CONTROL OF THE MANAGEMENT IT IS IMPOSSIBLE TO OPEN OR TO COMPLETE THIS SHOW, NO REFUND OF ENTRY FEE WILL BE MADE.

THE SHOW-GIVING CLUB assumes no responsibility for any loss, damage, or injury sustained by the exhibitors, handlers, or to any dogs or property, and further assumes no responsibility for injury to children not under control of parents or guardians.

OUT OF STATE EXHIBITORS: Exhibitors from outside Wisconsin must comply with the following regulations: Wisconsin Department of Agriculture Rule enacted in 1954: No person shall import a dog over 6 months of age into the state unless it is accompanied by an interstate health certificate including thereon a vaccination for rabies, etc. Such vaccination shall be conducted not more than 12 months prior to entry. Provided that when chick embryo vaccination is used, such vaccination shall be conducted not more than 36 months prior to entry. An interstate Health Certificate shall be executed by a Veterinarian of the State of origin, showing animals identified thereon have been inspected and no infectious diseases disclosed, and to include a rabies report.

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color). Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
