ENTRIES CLOSE at the Trial Secretary's address, Wednesday, February 23, 2022 at 6 p.m. Central Time. After which time entries will not be accepted, cancelled, altered or substituted as provided for in Chapter 11, Section 6 of the Dog Show Rules.

Exhibitors please note: A RECORDING FEE and event fee will be required for each dog, and are included in the entry fees as mentioned herein. These fees are to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class, the fees are to be collected on the first entry only at each Obedience Trial. All fees are included in the entry fees listed. (American Kennel Club Rule, Chapter 11, Section 2).

MAKE CHECKS and money orders payable to K-9 OTC, Inc. (Returned check fee is \$20.00 and does not constitute a valid entry). Write class entered on face of check. No third party checks accepted.

ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS. Photocopies of front and back will only be accepted if legible. ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURE, FEES, OR <u>BACK OF ENTRY AGREEMENT</u>. <u>Illegible entries</u> will not be accepted.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Judge or barred from competition by action of the Show Committee. A full refund shall be made for an entered bitch that comes in season after entries close upon presentation of a statement by a licensed veterinarian. Notification must be in the hands of the Trial Secretary by 8:00 a.m. the morning of the show

SHOW HOURS are 7:30 a.m. to 6:00 p.m. central time. Dogs are not required to be at the show until scheduled time of judging. Judges will NOT wait for dogs. Dogs not needed for further judging will be excused.
