ENTRIES CLOSE at the Trial Secretary's address, Wednesday, July 24, 2024 at 8 p.m. Central Time. After which time entries will not be accepted, cancelled, altered or substituted as provided for in Chapter 11, Section 6 of the Dog Show Rules.

Exhibitors please note: A RECORDING FEE and event fee will be required for each dog, and are included in the entry fees as mentioned herein. These fees are to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class, the fees are to be collected on the first entry only at each Obedience Trial. All fees are included in the entry fees listed. (American Kennel Club Rule, Chapter 11, Section 2).

MAKE CHECKS and money orders payable to K-9 OTC, Inc. (Returned check fee is \$20.00 and does not constitute a valid entry). Write class entered on face of check. No third party checks accepted.

ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS. Photocopies of front and back will only be accepted if legible. ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURE, FEES, OR <u>BACK OF ENTRY AGREEMENT</u>. <u>Illegible entries will not be accepted.</u>

An interstate Health Certificate shall be executed by a Veterinarian of the State of origin, showing animals identified thereon have been inspected and no infectious diseases disclosed, and to include a rabies report.
