As a parent/guardian of a camper at Wilson's Rising Stars Youth Academy Summer Camp, I understand and agree to the following guidelines and expectations for behavior. These guidelines are in place to ensure a safe, respectful, and positive environment for all campers, staff, and families.

****1. Respectful Behavior:****

- I will encourage my child to treat all campers, staff, and property with respect.
- I will support camp policies on anti-bullying, inclusivity, and kindness.

****2. Communication:****

- I will maintain open communication with camp staff and inform them of any concerns or issues.
- I will update the camp with any changes to contact information or emergency details.

****3. Attendance and Punctuality:****

- I will ensure my child arrives on time and is picked up promptly at the end of the camp day.

4. ****Stay Safe:**** Use camp equipment and facilities safely and appropriately. Report any injuries or hazards to staff immediately.
5. ****Participate Actively:**** Engage in all camp activities with a positive attitude and to the best of your ability.
6. ****Keep Areas Clean:**** Clean up after yourself and help keep camp areas tidy.
7. ****Use Appropriate Language:**** Use polite and respectful language. Swearing, teasing, or inappropriate jokes are not allowed.
8. ****Be Inclusive:**** Make an effort to include all campers in activities and be mindful of others' feelings.
9. ****Stay in Designated Areas:**** Remain within the camp boundaries and inform staff if you need to leave an area.
10. ****Dress Appropriately:**** Wear suitable clothing and footwear for camp activities. Follow any specific dress guidelines provided by the camp.
11. ****Respect Personal Property:**** Do not take or damage others' belongings. Keep your own belongings organized and labeled.
