## **General Court News-Legislative Activities Suspension**

Due to the COVID-19 pandemic, the General Court has suspended all legislative activities until further notice with the exception of *remote public meetings*, *notices for which will be published in the House or Senate Calendar*. During this time, the State House and Legislative Office Building will be closed to legislative members, legislative staff, and visitors.

## **Legislative Update - HB 250**

From Gail Brown at the NH Oral Health Coalition:

We want you to know that the next phase of the bill for a Medicaid Adult Dental Benefit is scheduled to go to the Governor this week. You can contact Governor Sununu by phone at: 603-271-2121 or email at: <a href="mailto:GovernorSununu@NH.gov">GovernorSununu@NH.gov</a>.

HB250 requires the commissioner of the department of health and human services to solicit information and to contract with dental managed care organizations to provide dental care to persons under the Medicaid managed care program. This would apply to the Medicaid adult dental benefit and also move the children's comprehensive Medicaid dental benefit from a fee-for-service into a managed care system. HB250 was strongly supported in the NH House and Senate on a bipartisan basis. It is good policy.

If you support is bill, tell the Governor that you want him to sign HB 250 to support dental coverage for adults under the state's Medicaid program.

#### Talking Points:

Signing HB250 is the *doorway to responsible management of limited financial resources* especially during a critical health emergency. Personalize your request to your work, family, or need. Some suggestions of talking points are listed below. Your request can be short and does not need to cover all points.

• Establishes a managed care model for the delivery of Medicaid dental services for adults and children;

- Allows Medicaid provider dollars to be used for dental services to treat and repair adult dental disease before it becomes a costly medical crisis in the emergency department or inpatient hospitalization;
- Allows the timely treatment of dental disease supporting adult employment, student learning, and effective substance treatment and the avoidance of relapse related to pain; and
- Reduces the impact and cost of dental disease on chronic illnesses such as cardiac, pulmonary, autoimmune, dementia, and many other chronic illnesses and conditions.

## President George H.W. Bush Signing the 1990 Americans with Disabilities Act

The Americans with Disabilities Act (ADA) is federal legislation passed in 1990 that prohibits discrimination against people with disabilities. The law made it illegal to discriminate against a disabled person in terms of employment opportunities, access to transportation, public accommodations, communications, and government activities. The law prohibits private employers, state and local governments, employment agencies, and labor unions from discriminating against the disabled. The ADA also establishes requirements for telecommunications relay services. Title IV, which is regulated by the Federal Communications Commission (FCC), also requires closed captioning of federally funded public service announcements.

Under the ADA, employers are required to make reasonable accommodations in order for a disabled person to perform their job function.
