CHAIRMAN'S STATEMENT

The year ending March 2013 was a very challenging period particularly in fundraising for Asecondchance. Following the unfavourable economic situation that prevailed, cumulative income raised from several funders did have a significant increase in Asecondchance income. However we fulfilled all our promises made to our partners in East Africa.

The income raised in the year increased from £ 21,953 the previous year to £50,708 representing 131% increase. During this period, Asecondchance continued to cover operations costs from kind contributions from directors and volunteers thus incurring minimum operational expenses particularly on postage and stationery.

With this income, Asecondcahnce continued to support Child Opportunity Trust projects in Kenya in implementing activities in child health and survival project initiated three years ago, vocational training which is in its third year and completion of water projects in new areas.

The achievements made have been as a result of committed directors who have contributed both finances and their sweat equity to see the charity grow systematically.

The contribution of our donors particularly Guemsey Overseas Aid Commission, St Mary's Trust, Souter Charitable Trust, Allan and Nesta, Strathspey Charitable Trust, and Monica Rabagliati Trust was very instrumental in enabling Asecondchance to fulfil promises to the marginalised communities in Kenya.

Lastly, we are grateful for the Trustees' voluntary contribution, of office chair, desk, camera, mobile handsets and Photocopier/printer, to the Asecondcahce. The mobile handsets donated to our partner in Kenya have improved communication between the office and field.

We look forward to a better economic environment next year and hope it will be conducive for increased fundraising.

DIRECTORS' REPORT

The charity presents its annual report for the year ended 31st March 2013

STRUCTURE, GOVERNANCE & MANAMENT

- The executive committee comprises of four Directors who are Trustees of Asecondchance prepare a report, which is shared amongst them as they share responsibilities for the day to day management of the Charity.
- No director was recruited in the course of the year since the existing members concentrated on strengthening of Asecondchance as Company and Charity.
- The directors have a broad range of backgrounds that contribute significantly to the work and programming of Asecondchance's work globally.

GOVERNING INSTRUMENT

The charity was established under a Memorandum of Association established in January 2009 and is registered as a charity as well. The objects and powers of the charity and company are governed under its Articles of Association. In the event of the company being wound up, members are required to contribute an amount not exceeding £10

OBJECTS & ACTIVITIES

Asecondchance exists to facilitate change on issues affecting children, women and girls. Supporting them to realise their full potential and building capacity of local institutions supporting children and their families so that they can continue to provide the support needed to initiate change in their own societies.

Building capacity and supporting children and their families in the following critical areas:

- Education is a fundamental right and crucial for long term change and development.
 Many children do not have access to education and therefore live in poverty throughout their lives. These include: street children, orphans, young carers, children living with disability and other disadvantaged children.
- Promotes child protection and participation practices among children living on streets, communities, schools and local institutions. Facilitate access to information and opportunities to advance their lives.
- Supports children Ilving with HIV/AIDS and their families to mitigate the effects of HIV/AIDS. It supports children living with HIV and AIDS virus to realise quality life.
- Works to improve the health of malnourished children to see their fifth birthday. Partners
 with local communities and healthcare institutions to help improve healthcare and
 medical care.
- Facilitates participatory health education to increase knowledge and change attitudes in order to improve child survival.
- Works with expectant and lactating mothers to prevent pre-mature death of children at antenatal and postnatal.

- Promotes prevention and treatment of malaria, tuberculosis and other childhood diseases in order to prevent child mortality caused by preventable diseases.
- Women and girls are vulnerable in communities where we work, no meaningful change
 can happen in a society where women's and girl's rights are denied and have no
 opportunity to advance their Ilvelihoods. We promote equity and empowerment through
 strategies that promote women's rights, attack domestic violence and enhance women
 and girls access to education and financial services.
- We work with grassroots organisations, women forums and girls in communities and schools to promote their leadership and communication capability.

ACHIEVEMENTS & PERFORMANCE

The year under witnessed a significant growth in our income leading to accomplishment of our projects with Child Opportunity in Kenya. Having supported the implementation of programmes in Health, youth development and water, one of the directors was sponsored to visit the projects In Kenya and help in building the capacities of Child Opportunity Trust management. This was considered to be very important, particularly as the number of beneficiaries increase. The level of personal donations to the charity also continued to reduce with a view to determining the degree to which Asecondchance could operate without internal donations. However, most of the administrative infrastructure remained a donation as more efforts were placed on actual activities funded overseas.

The charity, informed by the learning shared from on-going activities on the ground, approved comprehensive strategies for the following programmes to improve the lives of children, women, youth and girls in needy circumstances:

- Advancement of education and training;
- Preservation and protection of good mental and physical health;
- Relief of poverty, sickness and distress
- · Relief of unemployment, including assistance to find employment; and
- Provision of recreational facilities in the interests of social welfare with the object of improving their conditions of life.
- Fund raising strategies and identification of donors for the programmes.
- Definition of partner organisation to work with in developing countries especially Kenya, Uganda and Tanzania.

In the coming year, Asecondchance intends to fundraise and implement the approved strategies to deliver set objectives and guide overseas partners to establish strategic partnerships with other existing institutions with an aim of benefiting from the already human and technical resources.

Financial Review

The key financial statements to be read in conjunction with this financial review are statement of Financial Activities on page 8, the balance Sheet on page 9 and notes on pages 10 and 11.

Total incoming resources in cash were £49,087 representing over 100% increase from the previous year. The philanthropic contribution was very insignificant and could only be considered

under technical and administrative support to the charity as the directors contributed both their skills and time as sweat equity for the management of the charity. Previous periods have depended on individual contributions in kind and cash on philanthropic basis.

The total foreign currency remitted during the year to fund projects was £42,064.5 representing 85.6% of the total cash income received by 31st March 2013 and more so from the restricted fund which was raised for this very purpose. The charity hopes to continue with this trend. In addition, Trustees donated 12 mobile phones worth £600 to support field officers in Kenya.

Risk Review

The directors continue to keep risk register and have identified major risks to the charity. The most severe risk to Asecondchance continues to be over dependence on directors for management volunteer services for operations. To mitigate these risks, Asecondchance will embark on ambitious fundraising and incorporate management costs in the project designs. Additionally, more funding trusts and foundations will be convinced to understand that their long term strategy on making contributions to Asecondchance will be important the development of the charity.

Statement of Directors' Responsibilities

Charity law requires the directors to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the charity as at the balance sheet date and of its incoming resources and application of resources, including income and expenditure, for the financial year.

In preparing those financial statements the directors are required to:

- · select suitable accounting policies and then apply them consistently;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in financial statements; and
- Prepare the financial statements on the going concern basis unless it is inappropriate to assume that the charity will continue in business.

The directors are responsible for keeping proper accounting records which disclose, with reasonable accuracy at any time, the financial position of the Charity and enable them to ensure that the financial statements comply with the *Companies Act 1985 to 2006*. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud or other irregularitles.

Auditors

As a charity, Asecondchance was registered In January 2009. By 31st March 2012, the charity had a total turnover of £23,330 for the year. For the current year, the turnover has increased to £50,708 resulting from increase in donations from our development partners.

The charity has therefore involved an Independent Examiner to look at the accounts.

ACCOUNTING POLICIES

Basis of preparation:

The financial statements have been prepared in accordance with all applicable accounting standards, as modified by SORP. The accounts have been drawn up in accordance with provisions the Charities (Accounts and Reports) Regulations 2008 and the Companies Acts, and include the results of the charities operations which are described in the Trustees' Report, all of which are continuing.

Advantage has been taken of Section 396(5) of The Companies Act 2006 to allow the format of the financial statement to be adapted to reflect the special nature of the charity's operation and in order to comply with the requirements of the SORP.

The company has taken advantage of the exemption in Financial Reporting Standard No. 1 from the requirement to produce a cash flow statement.

The particular accounting policies adopted are set out below.

Gifts in Kind

Gifts in kind are accounted for at a reasonable estimate of their value to the charity or the amount actually realised.

Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity.

Gifts in kind for use by the charity are included in SOFA as incoming resources when receivable.

DIRECTORS AND OTHER RELATED PARTIES

No payments in form of salary, allowance or professional fees was made to benefit any director as a member of the board of trustees.

PUBLIC BENEFIT

The charity acknowledges its requirement to demonstrate clearly that it must have charitable purposes or 'aims' that are for the public benefit. Details of how the charity has achieved this are provided in the Trustees' report. The Trustees confirm that they have paid due regard to the Charity Commission guidance on public benefit before deciding what activities the charity should undertake.

INDEPENDENT EXAMINER'S REPORT ON THE ACCOUNTS

Report to the trustees/ members of ASECONDCHANCE Charity Ltd on the accounts for the year ended 31st March 2013 set out on pages 2 to 11.

Respective responsibilities of trustees and examiner

As described on page 9, the Charity's trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the financial statements. The trustees are satisfied that the audit requirement of Section 144(1) of the Charities Act 2011 (the Act) does not apply, and that there is no requirement in the governing document or constitution of the Charity for the conducting of an audit. As a consequence, the trustees have elected that the financial statements be subject to independent examination.

Basis of independent examiner's statement
