1. Information We Collect

1.1 Personal Information

You may voluntarily provide us with information including, but not limited to:

- Name for identification and communication.
- Email Address for updates, donation receipts, newsletters, and alerts.
- Phone Number for direct communication or emergency contact purposes.
- Mailing Address if applicable, for correspondence, thank-you letters, or event invitations.
- Payment Information collected securely via third-party processors for donations, event registrations, or merchandise sales.

1.2 Non-Personal Information

We automatically collect certain data when you interact with our website, such as:

- IP addresses
- Browser and device information
- Pages visited
- Cookies and similar tracking tools
- 1.3 Information from Third Parties

We may collect information from partners such as fundraising platforms or grant management systems to improve our outreach and services.

1.4 Sensitive Information

We do not intentionally collect sensitive personal data (e.g., race, religion, health data) unless required by our programs and with your explicit consent.

2. How We Use Your Information

We use the information we collect for the following purposes:

- 2.1 Service Delivery and Support
- Providing housing, support, and case management to clients
- Responding to inquiries
- Processing donations and issuing tax receipts
- Coordinating volunteer opportunities
- 2.2 Communication
- Sending updates, newsletters, and thank-you messages

- Preventing fraud and misuse
- Protecting the rights and safety of our organization and stakeholders

3. Information Sharing

We never sell your personal information. We may share information under the following circumstances:

3.1 With Service Providers

Trusted vendors who assist us in website hosting, data storage, donation processing, or communication. These providers are bound by confidentiality agreements.

3.2 Legal Requirements

We may disclose personal data when legally required, such as in response to subpoenas or to protect our rights and property.

3.3 Program Reporting (De-Identified Data)

We may use anonymized, aggregated data for grant reports, impact assessments, or public communications.

4. Data Security

We take reasonable steps to secure your data, including:

- Secure Sockets Layer (SSL) encryption on our website
- Data access restrictions based on roles
- Regular security reviews of third-party services

However, no data transmission is 100% secure. You share information with us at your own risk, and we recommend safeguarding your own devices and login credentials.

5. Your Rights

Depending on your location, you may have rights under privacy laws to:

- Access the personal information we hold about you
- Correct inaccurate information
- Request deletion of your data (subject to legal or operational obligations)
- Opt out of marketing communications at any time
