

Helotes residents will get to see and hear all eleven candidates in the city's first regular election at a "Meet the Candidates" session scheduled for 3 p.m. on Sunday, March 28, at the Lion Club Parrigin Pavilion on Bandera Road.

It will be sponsored by the Helotes Park Estates Homeowners Association and the Helotes Lions and Lionesses Club. The public is invited and admission is free. The incumbent Helotes

mayor, Tom Beatty, and all five incumbent city council members have filed for reelection. They went into office last November in the special election held following incorporation of the city.

For the new election on Saturday, April 3, Mayor Beatty has drawn opposition from Chuck Lee, Bennie Lyon and Frank Thompson. Lee ran for city council in the November election, and Lyon ran for mayor. This is Thompson's first race.





Biological Control

Needed For Fire Ants

AUSTIN-"Trying to destroy fire ants with Amdro is like trying to kill an elephant with a b-b gun," State Representative Dan Kubiak (D-Rockdale) said today.

Kubiak, Chairman of the Select Committee on Fire Ants, said Amdro was at best a stop-gap measure that might provide temporary relief. "The fire ant spread has reached epidemic pro-portions and there is currnetly no known remedy to totally destroy them," Kubiak said.

The fire ant has spread across more than 100 coun-ties in Texas. Birds, bees, livestock, earthworms, and humans are susceptible to attack. Fire ants, which can travel up to 30 miles per year, also have caused tremendous property damage.

Fire ants started out a problem primarily in the rural area. However, infestations have been found in

many large cities," Kubiak added. "This is a problem of great magnitude for all affected areas," he stated.

"I believe that the key to destroying the fire ant on a permanent basis is a coordinated, concerted effort by all of the nine states that are infested," Kubiak said. He also added that a buffer zone around the infested area should be found to try and prevent additional spreading. "Once the bufferzone has been formed, hopefully the ants can be contained until a permanent solution can be found."

Kubiak added that, in his opinion, biological controls will be the best solution. "We need to find the natural enemies and predators of the fire ant," Kubiak said.

Kubiak said his subcommittee will be visiting infested areas of the state to allow everyone an opportunity to testify about the problem.

People using Amdro should carefully allow instructions on its application. The chemical should be used in very small amounts, sprinkled around the mound so as not to disturb the ants. Also, Amdro should only be used on a dry day with a temperature above 60 degrees. Amdro should be used within five days of purchase in order for it to be at peak effectiveness. Only a tablespoon per mound is needed.

Harlon Copeland, born in Abilene, Texas, moved to San Antonio at age nine, attended Sout's San An tonio High School, and completed his training at San Antonio College


He is married and has one son, a graduate of Holmes High School and St. Mary's University, who is a Captain in the Army stationed at Fort Sill, Oklahoma.



Boerne Historical Tour



Another of the places of interest on the Boerne Historical Tour sponsored by the Boerne Area Historical Preservation Society on Sunday, May 2, 1982, will be the log cabins of the old William Vogt-Clegg place at 221 Plant Street.

William Vogt was born in Germany in 1826. He married Ernestine Neihser of Germany in 1850 and they immigrated to America in 1852. They came through Indianola and moved to Boerne in 1856.

They purchased 39 3/3 of land from William Dietert in 1859 and built their first oneroom log cabin in 1860. As their family grew, more log cabins were built, all in a line, with each having outside entrances. Mr. Vogt built a two-room limestone block house in front of the log

cabins in the 1870's, and added more rooms before he died in 1912.

Mr. L. B. Clegg, then owner of the Clegg Printing Company in San Antonio, bought the remaining 3.8 acres of the William Vogt Estate in 1919. They have retained the log cabins in their original state.

Mrs. Agnes Clegg, who currently owns the cabins, uses the three rooms as guest cabins. Practically suited to the forest-rich environment, the cabin is constructed of hardwood with dovetail notching to join the logs at the corners, a

device that displays a more finished appearance and makes the house tight against the weather. It has a gabled roof with rough-hewn planks filling in each gable end and a wooden shake roof



Ribbon cutting ceremonies are part of the history of Helotes, and they are not complete without the presence of a mayor Here in November of 1976, Joe Algueseva, local businessman serving as Honorary Mayor of Helotes succeeding John T. The FDA has confiscated the drugs from several lookalike manufacturers on grounds that they are counterfeit drugs prohibited by the U.S. Food, Drug and Cosmetic Act. In addition, the U.S. Postal Service has filed complaints charging the mail-order companies with misrepresenting the safety of their products.

The main problem is that only 13 states have passed laws to combat look-alike drugs. Texas is not among the 13.

The first five months of independent government for the city of Helotes have been an exciting time and, yes, sometimes a trying time, but we have accomplished much for our city.

We have Emergency Medical Service. We have a law enforcement officer who, though he is only paid for 40 hours a week, often works from 50 to 70 hours to protect the properties and citizens of our city.

There is harmony between the Helotes Volunteer Fire Department and the city as evidenced by the location of the rent-free city hall.

We have made agreements with and have collected pass-through charges from the San Antonio City Public Service Board and from the UA-Columbia Cable Company. These payments to Helotes will help in reducing the tax burden for all of us in our new city.

AND, even though our city will not be receiving tax money until October, we have been able to do all of this without borrowing one penny from any lending institution. Better yet, through the pass-through charges paid to us and the generosity of the Helotes citizens who donated funds to see their city off to a good start, we still have approximately \$5,000 in our city account.

There are some of you who have not always agreed with what I advocated for our new city, but, believe me, I have asked only for what I thought best for Helotes. I have not made my decisions on what would be best for me, or would better only a fraction of this new city, but would in the long run be beneficial for the city of Helotes.

There are those who would try to convince you I am trying to set up public housing in Helotes. There is nothing that could be farther from the truth. True, there is a need for public housing in some areas of Bexar County, but the Helotes area is not one of them. I worked against public housing before in this community and successfully prevented a project being designed for the corner of Scenic Loop Road and Highway 16. I will continue to oppose public housing in Helotes and would never introduce anything into this city which would result in forced public housing.

I did not move to Helotes with the intent of seeking public office. However, I was urged by a large segment of this community to run for mayor because of my background in city and state government and because of my experience gained as chairman of the Helotes Incorporation Committee. Once elected as mayor, I refused to be pressured by a select few who were either gathering votes for this coming election or who were interested in bettering their business situation.

There is still much we need to do to assure a pleasant and practical future for Helotes, and it is my belief that once this election is over, we can settle down and concentrate on the issues relevant to our city

Helotes is a beautiful city, populated by people who are sincerely concerned with the future of their town. Let's all pull together - we can accomplish a great deal more if we work as a team.

Worden School Will Celebrate 40th Year

The first school of social work in the state of Texas celebrates its 40th anniversary this year.

sary this year. "Since March has been designated National Social Work Month by the National Association of Social Workers, this is an appropriate time to remember the Worden School of Social Service's 40 years of commitment to the community," said Dr. Louis Tomaino, dean of Our Lady of the Lake University's Worden School

In 1942, a one-year school of social service opened on campus. Over 2,000 students have graduated with master's degrees in social work since the school began awarding the M.S.W. in 1950.

A study done by Worden Staff indicates that within two and on-half years after graduation, at least one-half of the school's master's degree recipients occupy either supervisory or administrative positions in social service, according to Tomaino.

Sister Mary Philothea Thiry, a native of Lorraine, France, and Superior General of the Congregation of Divine Providence from 1925 to 1943, spearheaded the movement to establish a school of social service. Encouraged by the then Archbishop of San Antonio, Robert E. Lucey, the oneyear school of social service was opened on October 1, 1942. In August, 1949, the name of the school was changed to the Worden School of Social Service in recognition of the interest and support of the Worden family of San Antonio.


At the present time there are over 200 students in the graduate program at Worden and close to 100 undergraduates.

Worden's curriculum concentrates on preparing students for work with individuals, families, groups and communities. It is especially noted for its preparation for social work in bilingual-bicultural settings.

The faculty of the Worden School includes nationally recognized experts in the fields of child and family services, training of alcoholism counselors, and cultural aspects of the counselorclient relationship.

Phone Best

For Aid

Some people apparently find it hard to believe that almost all Social Security business can be handled by telephone, from changing an address to applying for retirement, disability, or survivor benefits, according to William M. Archuleta, Social Security distict manager in San Antonio.

This may explain why many people stop at the Social Security office to get answers to their questions, pick up a leaflet, or apply for benefits. They may end up waiting in line or wasting gas (and energy), Archuleta said.

For several years, Social Security has been geared up to handle most of its business by telephone, a direct result of the steady increase in the volume of business from new programs, n w legislation, and new clients. Teleservice centers around the country are staffed to provide service by telephone. Also, district offices—some 1,300—have personnel trained to handle almost all Social Security business by phone so a special trip to the office is not necessary.

The best times to call the office generally are the last two weeks of the month, the latter half of most weeks, and in the afternoon. 



The number of students slightly over the previous nrolled in Texas' seven year -- from 64,195 to 65,497.

In Texas, medical school enrollment increased from 3,811 to 4,150 students, while the number of graduates roses from 741 to 938 over the same one-year period. The number of first-year medical students increased slightly – from 1,123 to 1,137.

Reflecting a national trend, the number of women enrolled in Texas medical schools increased from 860 to in 1979-80 to 1,000 in 1980-81. Statistics for 1980-81 show that women comprised 24 percent of Texas' medical school enrollment and 26.5 percent of the nation's medical students.

Texas continued to rank third in the number of residents entering medical school - 1,044. Leading were New York with 1,941 and California with 1,428.

Northside plans 5th High School

Northside District The school board awarded a contract at its March meeting recently for preliminary designs for the fifth Northside high school, to be built by 1984. Several sites are under consideration for the school, but it probably will be built on the far west side of the district near the Great Northwest area.
