Helotes Park To Get New Storage Tank

The board of directors of the water district serving Helotes Park Estates has called a bond election for Saturday, Sept. 29, to authorize the issuance of \$190,000 in bonds to pay for improvements to the water

A water shortage in Helotes Park Estates is a distinct possibility if the improvements are not made, they said. Even now some residents must go without water or put up with low water pressure, they added.

Improvements to the system chiefly would be the erection of a 273,000-gallon standpipe storage facility on the existing tank site on Rafter S Trail, with an automatic pressure sustainer valve between the new tank and the one on $Circl \epsilon$ A Trail.

The bonds can be paid off through an increase of only about 10 cents per \$100 valuation of properties in Helotes Park Estates, the directors said. The current tax rate is 50 cents per \$100 valuation.

Voting will be held from 7 a.m. to 7 p.m. on Sept. 29 in the water district office in Helotes Park Village. Absentee voting is now underway and will continue through Sept. 25.

A meeting to discuss the proposed improvements and the bond issue will be held Tuesday, Sept. 25, beginning at p.m., in the Forest Hills Presbyterian Church.

Hill Country Water Good

A new report detailing the major underground water supplies in the Edwards Plateau region has been released by the Texas Department of Water Resources.

The report states that more than 450,000 acre-feet of water is available annually from five principal aquifers with about 308,000 acre-feet of the total available each year from the Edwards Trinity (Plateau) and alluvium aquifers. Other less productive but important aquifers—the lower Creta-ceous, Hickory, and Ellen-burger-San Saba—are also

The water in general is very hard but suitable for municipal,

industrial, and agricultural purposes. Varying amounts of sulfate, chloride, and fluoride are contained in water from wells primarily in the central and western parts of the region; however, the water is

being used with no apparent harmful effects.

Pumpage from all aquifers in the Edwards Plateau in 1972 was about 86,000 acre-feet, of which about 70 percent, or 62,000 acre-feet, was produced

for irrigation. Over 36,000 acrefeet of the 1972 irrigation pumpage occurred in Glasscock and Reagan Counties.

In the northwestern part of the Plateau, more water is being removed than is being recharged, particularly in areas of Ector, Glasscock, Midland, and Reagan Counties, where water levels are declining rapidly due to heavy pumpage.

Areas particularly suited for additional, future development of ground water are in the central and southern parts of the region, the report shows. specifically in western Schleicher, northern Sutton, central

The Department inventory of wells includes data collected from June 1975 to February 1977 from 694 selected wells.

Q: Recently I read in the paper about motorists being stopped for speeding. If they couldn't pay the fine immediately, in cash, they were taken to jail. Is this legal in the state of Texas?

A: A Texas resident driving a licensed Texas vehicle must be issued an order to appear in court for a speeding violation if the motorist gives his written promise to appear.

However, non-residents are often unable or unwilling to appear in court at a later date. For this reason, non-residents cited for speeding may be taken either into custody until a cash bond is posted or may be taken directly minimal fee. before a magistrate for disposition of the case and payment of

Q: Can a will be written for me to allow my wife and children to avoid inheritance taxes?

A: Inheritance taxes which may be imposed on your estate after you die cannot be avoided simply by a provision in your will. However, inheritance and estate taxes can be minimized by proper estate planning. For example, proceeds from a life insurance policy on your life may not be taxed if your wife owned the policy and paid from her separate monies. This may remove the policy from your taxable estate.

Q: My husband owned a farm and had four grown children from his first marriage when we married 15 years ago. What interest in the farm would I be entitled to, if he died?

A: If your husband had a valid will at his death, you would receive whatever part of his interest in the farm he provided for in the will. If he died without a valid will, various factors would determine your property rights. These factors would include whether the farm was your husband's separate property, or whether it was community property of your husband and his former wife.

Q: I'm a middle-aged man of modest income and savings, married, have three children, and would like to draw up a will. Must I consult a lawyer, or is there another way that may be less expensive?

A: The number of factors involved in drafting a will, ranging from the choice of a guardian for children to coordination of life insurance, are so varied that each will should be individually prepared. Your local or statewide lawyer referral service can direct you to a lawyer familiar with estate planning who will provide 30-minute consultation for a

Q: Problems keep building up and I'm seriously considering getting a divorce. If I do it, I want to get it over with as quickly as possible. How long does it

take to get a divorce in Texas?

A: After the divorce petition is filed, the law requires a sixty-day waiting period. You could get back together during that time and drop the proceedings. After this 60 days, the final hearing on the divorce can be scheduled. The exact date would be subject to the caseload of the district court and any complications or problems in your case.

Q: I have written a will naming my sister the beneficiary of a considerable amount of money. I want to be certain the money stays in the family. If she dies, will her husband and children be entitled to any of that money?

A: If your sister dies before you do, your gift to her will lapse and pass instead with the residue of your estate.

If, however, your sister receives this money after your death, it will become part of her estate and will go as she directs



L. 93-234), 87 Stat. 980, which added Section 1363 to the National Flood Insurance Act of 1968 (Title XIII of the Housing and Urban Development Act of 1968 (Pub. Heaters Need Check-Up Now

One of the most important steps a householder can take this month to insure the safe and efficient operation of his heating equipment is to have it professionally serviced in advance of the heating season. according to Lt. Jesse Sanchez of the San Antonio Fire Depart-

Every year the San Antonio Fire Department and the City Public Service sponsor a joint safety campaign in an effort to reduce the injuries and deaths which occur locally as a result of operating faulty heating equipment.

Unless a person has mechanical aptitude and a service manual giving detailed instructions on how to service and adjust that particular brand of heating equipment, it is far better to have a professional service man do the job every year, according to Sanchez.

Among the tasks performed by a service man are cleaning the heater and making sure the air intakes and venting are clear and unobstructed, changing filters, oiling the motor and fan, checking the heat exchanger, checking and adjusting controls, lighting the pilot and making sure the unit is properly adjusted to burn with a blue flame rather than orange, which signals improper combustion and possible

Sanchez emphasized that central units, floor furnaces, wall furnaces and through-thewall furnaces all need a thorough checkup each year. Room heaters need to be blown out with compressed air and the flame adjusted. The unit and metal hose should also be checked for gas leaks, Sanchez

For householders buying new heating equipment, the CPS maintains a free information service on the comparative advantages of various types of heaters, the correct size to buy, and the comparative efficiency of various makes of heating equipment and all other gas and electric appliances. 
