

Word O' Mouth has it that more than 60 absentee votes will have been cast by 7 p.m. this Eve and from then on out, it's countdown to the big election day, Nov. 3. Amendments may occupy the State's voters, but here in Helotes it's the Mayor and his Council that count.

Word O' Mouth has it that the witches and clowns and Hallowe'en Trick or Treaters will be out. But then the big party at the Lions Club for the elementary children and the big event at Our Lady of Guadalupe Church CCD Building for middle schoolers should cut down on the bell-ringers and provide safe fun

Tomorrow Hallowe'en.

The Leon Valley Historical Society recently toured Gallagher Ranch with its historic setting and early Helotes history still growing. # First City Election Brings Out Feverish Campaigning Activity



This is Helotes, officially a city since Aug. 8, when residents approved incorporation. New Helotes will get a city government in the election to be held next Tuesday. The city extends from just beyond Toepperwein's and the new Helotes Bank on the right, to just beyond El Chapparral in the upper left. It widens out to include the older units of Helotes Ranch Acres, Downtown Helotes, and Helotes Park Estates. A 500-ft. corridor also runs along Galm Road to widen out and include the new units of Helotes Ranch Acres in the lower left. The city limits go north along Scenic Loop Road to the Echo office.

Political campaigning has reached an unexpected high pitch as Helotes goes into the last weekend before the first municipal election on Tuesday, Nov. 3.

The three mayor candidates, Tom Beatty, Pete Cantu and Bennie Lyon, particularly have been releasing a barrage of signs, circulars, advertisements, and telephone campaigns full of charges and counter-charges. Each is confident of victory, although almost nobody else in Helotes is willing to call the election.

"It could be a landslide in either of three directions, or it could be a toss-up with the three splitting the votes rather evenly," said one political observer. "No doubt about it, they are all three campaigning like veteran politicians."

The victory will go to the candidate with the biggest number of votes. There will be no run-off. In this election the victor will be determined by a simple plurality of the votes.

"The only problem would be if two of them tied for the highest number of votes," said Election Judge Barbara Galland. "Then some way would have to be decided to determine the winner. The law is vague on this point, but of course it is a remote possibility that two would tie for the most votes."

Mrs. Galland reported that 56 absentee ballots had been cast through Thursday, Oct. 29, with one more day of absentee voting to go. It is

being conducted in the PARC building at the Helotes Hills United Methodist Church and has been going on since; Oct. 14. The absentee voting station will be open from 8 a.m. to 5 p.m. Friday.

The regular voting on Tuesday will be conducted in the kitchen of the Helotes Hills United Methodist Church -- not in the PARC building. The polls will be open from 7 a.m. to 7 p.m., with all registered voters living within the new city limits eligible to cast a ballot.

The campaigning of the thirteen candidates for the five aldermen posts to be filled by Tuesday's election has varied from no activity to spasmodic activity to a sustained campaign.

The alderman candidates, in alphabetical order, are: Guy Burnett, Pete Crow, Henry Daughtry, Jr., Leonard Hill, Mike Krisak, Chuck Lee, Rudy Loeffler, Chester McCarter, Moon Mullins, Harry Olson, Jim Perry, Verna Thompson, Pat Wootton. Mrs. Thompson is the only woman candidate for

No date has been set for the swearing in of the victorious mayor and five aldermen, and no site has been selected for the temporary Helotes City Hall.

Voters Tuesday also will be asked to cast votes for or

against seven proposed amendments to the Texas Constitution and to pick between two candidates for District Clerk of Bexar County. All registered voters

in the greater Helotes area may vote on the amendments and the District Clerk candidates whether the voter lives in the City of Helotes or not.


4. My family and I plan to remain in Helotes and to continue to enjoy its quiet charm for many years to come.

The Texas Republican said heavy losses may eventually have an impact on more than three million acres of trees in nine states from Texas to Virginia. Oak decline is associated with oak wilt - the most destructive disease of oaks in the upper Mississippi Valley.
