

REGULAR MONTHLY MEETING WEDNESDAY, APRIL 24, 2013 7:00PM

The Orrock Township Board met in regular session, on Wednesday April 24th, 2013 at 7:00pm, at the Orrock Town Hall, 26401 – 180th St. NW, Big Lake, Minnesota.

Chair Jeff Jones, Supervisors Shane Berg, Ron Dolly, Michael Eisinger & Mike Meier, Treasurer Laura Jones Clerk Brenda Kimberly-Maas and the township's Counsel Jeff Thompson were in attendance. Several citizens were also in attendance.

The meeting was called to order by Chair Jones, with the reciting of the Pledge of Allegiance at 7:00pm.

APPROVAL OF APRIL REGULAR MEETING AGENDA:

Motion made by Supervisor Eisinger, to add a line item under 8. <u>Old Business</u> and move line item b. <u>Jerry Petersen Payroll</u> <u>Tax Judgment/Counter Claim</u> down making it line item c. to the April agenda. Clerk Kimberly-Maas explained that any questions would likely be answered under the current line item b. The Motion died for lack of a second.

APPROVAL OF MARCH MINUTES

Clerk Kimberly-Maas noted that Gary Goldsmith had pointed out that the month was mistyped in two locations. The modification was already made to the electronic document. Supervisor Meier request that the addition of "by Shane Berg" be added to this sentence "A sample of that was given to Corrie Silverberg." Under the Open Forum/Wayne Chermack paragraph.

SHERIFF'S REPORT:

Commander Steve Doran was in attendance and provided the board and gallery with The Sheriff Department's monthly call report, for Orrock Township. Cmdr. Doran reported that the call log was typical for Orrock Township.

<u>BIG LAKE FIRE BOARD</u>: Supervisor Meier read his notes about the Big Lake Fire Board meeting, on April 4th, 2013. Noting that a scheduled burn of the structures at the former Shady Acres Campground, a Smelt Fry was going to be held at the fire hall on 4/26/13 to benefit the BLFD and that BLFD will be purchasing a First Responder unit from the BLPD.

<u>SHERBURNE COUNTY TOWNSHIP QUARTERLY MEETING:</u> Supervisor Meier and Chair Jones attended the meeting, on 4/17/13. They relayed information about the meeting. Information on noxious weeds, conservation measures of the SWCD and the gopher foot bounty was given to them at the meeting. They noted that some of that noxious weed information is available at the Orrock Town Hall for residents to review. They also found out that if you should miss your township's cleanup day you are allowed to go to any clean-up day with in the township.

OPEN FORUM:

<u>THE BOARD HEARD FROM NANCY RIDDLE AND DAVE LUCAS - SHERBURNE COUNTY PLANNING & ZONING OFFICE:</u> Nancy and Dave gave a brief overview of what the Planning and Zoning Office had been working on in 2012, such as the Feed Lot Ordinance and Solid waste Moratorium. They spoke about the SCORE grants that are available through the county, how those were distributed in 2012 and how to apply for them. It was noted that most all of the county ordinances are available through the county website. Supervisor Dolly asked Nancy and Dave to look into a residence where there were a large number of tires that were piled up.

<u>THE BOARD HEARD FROM GARY GOLDSMITH</u>: Gary brought to the board's attention items that need to be available to the public prior to and during the board meeting. He also noted that the open meeting law is very restrictive and that the board must be mindful of it when seeing each other outside of public meetings. Clerk Kimberly-Maas also gave examples of things the board cannot do, or they will be in violation of the open meeting law.

<u>THE BOARD HEARD FROM JOHN RIEBEL COUNTY COMMISSIONER:</u> John updated the board with information from recent county meetings. He noted that we would be receiving invitations and a solicitation for donation to the NEMO program. This is put on by the Soil and Water commission through the U of MN Extension service. He also noted that our representative sits on the Blue Hill Board of Supervisors. Update on the CR 15 – Work is beginning.

<u>THE BOARD HEARD FROM JAY MORRELL - JME:</u> Jay was at the meeting to answer any concerns or questions about the snow season. Chair Jones mentioned that after the drivers acquainted themselves with the roads, the work of the drivers was much better. He also noted that damage that was done on 245^{th} during the last snow fall would be corrected.

OLD BUSINESS:

<u>ANNUAL CLEAN-UP DAY:</u> Chair Jones reminded everyone that the Annual Clean-Up day is Saturday May 18th, 2013. And if residents miss that day, they are allowed to visit any clean-up day in the county. The contract that is made between Sherburne County and municipalities, state that any county resident must be given access to the municipalities event, even if the participant lives outside of that particular municipality.

<u>PAYROLL TAX RECOVERY:</u> Chair Jones and Jeff Thompson, Orrock Township's attorney, presented the board with the particulars of the events leading up to the contact of Jeff Thompson, settlement and dismissal judgment against Jerry Petersen. Supervisors Eisinger and Meier noted that they disagreed with the decision made on behalf of the township by the township's attorney. Further discussion by the board was heard about the events that occurred during the March regular board meeting and how they affected the resulting decision of the judgment settlement.

Additional conversation was made about the types of business that the township board could address and items that are not appropriate to be brought to the township meetings and be addressed by the township board.

NEW BUSINESS:

<u>INCLUSION OF AGENDA ITEMS</u>: The board discussed the timeline for inclusion of items on the agenda and more detailed information to be delivered to the board members prior to the meeting. The suggestion is that agenda items are to be submitted to the Clerk or Chair no later than seven (7) days prior to the upcoming monthly board meeting to be included in that month's agenda. Should there be additional items presented after that cut-off date, the item will be heard under the Open Forum or will need to be placed on the following month's agenda.

<u>REVIEW OF TOW EXCAVATION PERMITS</u>: Permits from Connexus Energy and Windstream Communications were reviewed by the board and the board had no concerns with the permit applications.

A separate line item within the accounting system should be created to accurately project these costs.

Supervisor Berg and Ross Abel looked at a map of 245th, discussed possible the drainage concerns and correction of the drainage concerns.
