The Orrock Township Board met for the purpose of performing the Annual Board of Audit, on Wednesday February 26, 2014 following the regular monthly meeting, at the Orrock Town Hall, 26401 – 180th St. NW, Big Lake, Minnesota.

PRESENTATION OF THE AUDITED BOOKS
