The Orrock Township Board met in regular session, on Wednesday July 30, 2014 at 7:00pm, at the Orrock Town Hall, 26401 – 180th St. NW, Big Lake, Minnesota.

Chair Michael Eisinger, Vice Chair Mike Meier, Supervisors Shane Berg, Charles Gotzian & Eric Peterson, Treasurer Laura Jones and Clerk Brenda Kimberly-Maas were in attendance. Jeff Row of WSB and several residents were also in attendance.

ADDRESS SIGN ORDINANCE: Supervisor Meier addressed the Board about the possibility of creating an Ordinance for the payment and installation of address signs within the township. Mike had reviewed some other township's policies/ordinances already and felt that Orrock should consider changing the current method of obtaining and installing address signs. The Board felt the ordinances and policies that Supervisor Meier had gathered, could be compiled into one that considered current costs and be presented to the Board, for consideration. Supervisor Meier was charged with creating such a document. The matter will be reviewed again in August.

ROAD COMMITTEE REPORT

ROAD AUTHORITY: Supervisor Gotzian reported that there are areas that need attention.

There is a fairly large pothole on 233rd near 182nd that should be repaired.

Roads in need of shoulder repair from washing/4-wheeler damage:

168th St. NW off from CSAH 4 235th Ave. NW off from CSAH 5 231st Ave. NW off from CSAH 15 233rd Ave. NW off from CSAH 15

Clerk Kimberly-Maas will call County Public Works to see if these areas are within the County Road ROW.

Work to be done in the fall is grading of 245th Ave. NW and 253 ½ around Ann Lake due to washing.

There is some burrowing under 280th Ave that should be looked at.

The post that has a stop sign mounted on it at 165th St. NW and 257th Ave. should be replaced.

Supervisor Gotzian noted that the 180th St. had been graded.

The post with street signs at the end of the vacated portion of 239th Ave. NW has been removed.

A stop sign ahead sign on 241st Ave. NW is also very faded and should be replaced.

Chair Eisinger asked to have placed four-wheeler damage discussion be placed on the September agenda.

ROAD ENGINEER: A quote to fix the pothole on 233rd Ave was presented and reviewed by the Board. Another quote will be obtained to fix the pothole will be obtained. The Board would like to see two quotes to cut out the pavement and pack it with a temporary substance, as well. It was suggested that the Board consider the section of 253rd east of 180th, be considered for possible vacation.

The pavement management plan was on schedule to have the final product available to the Board in October.

Jeff Row also asked, for authorization to advertise, for bids the crack filling project.
