

PUBLIC HEARINGS – VACATIONS PORTION OF 273RD AVE. NW WELL & WATERLINE EASEMENT WEDNESDAY, AUGUST 27, 2014 6:00PM REGULAR MONTHLY MEETING WEDNESDAY, AUGUST 27, 2014 7:00PM

The Orrock Township Board met in for the purpose of Public Hearing in the matter of vacating a portion of 273rd Ave. NW, and vacating the Township's interest in an easement over a well and water line access in Winter Meadows, on Wednesday August 27, 2014, beginning at 6:00PM.

Chair Michael Eisinger, Supervisors Charles Gotzian & Eric Peterson were in attendance. Vice-Chair Mike Meier, Supervisor Shane Berg, Treasurer Laura Jones and Clerk Brenda Kimberly-Maas were in absent. Land owner, Clint Corrow, County Commissioner John Riebel, town residents Bob Hassett and Wayne Chermack and Township Engineer, Mike Nielson were also in attendance.

The Public Hearing was called to order by Chair Eisinger, and the Pledge of Allegiance was recited at 6:00PM.

Chair Eisinger Opened for Public Comments the matter of the vacating a portion of 273rd Ave. NW.

Chair Eisinger addressed the gallery noting that all interested landowners has been served the necessary paperwork and the public meeting notices were both published and posted at least 10-days prior to this Public Hearing.

John Riebel asked if anyone uses the road. Chair Eisinger noted that some Livonia residents may use it but mostly used for people to dump trash. If were to be developed, the developer would need to bring it up to code. He stated that the cost to maintain it is higher than the process to vacate it.

No Further comments were made.

Chair Eisinger closed comments in the matter of vacating a portion of 273rd Ave. NW

Chair Eisinger Opened for Public Comments the matter of the vacating the township's interest in the easement over a well and waterline in Winter Meadows.

Bob Hassett asked how much to upkeep the well.

Chair Eisinger noted that the well is not currently in service, the pump is stuck in the casing, the well is capped and casing is below grade. The main concern is that rain and ground water is leaking into the well. There is the potential of contaminating the aquifer and it is his opinion that it should be sealed since it is abandoned. He also noted that the Township has never formally accepted or utilized the easement that was granted in the late 1990's. It could cost \$1000 - \$10,000 to pull the pump and get the well in functioning condition. He stated that the Township would have to put in a road to allow for access to the well. This would also be costly and the easement may not even be large enough to put in the 96' diameter cul-de-sac, required by law, for fire trucks. There would also be liability placed on the township, should the service be installed. John Riebel asked, "So your lawyer has said you should abandon the well?"

Supervisor Gotzian clarified that abandoning the well is not what is being done. Chair Eisinger further clarified that the Board is vacating the easement, for access to the well, the well itself and waterline(s) that bring the water to the surface. At this point it would appear that the cost of getting the well up to code and placed in service to use as a fire truck filling station, would cost more than the Township Board feels would benefit the residents of the township. Rather than hold on to the easement and have the well potentially be leaking contaminants into the well and ground water, the Board feels that the easement should be vacated, giving all control of the well, back to the landowner.

No Further comments were made.

Chair Eisinger closed comments in the matter of vacating the easement of the well and waterline(s).

Chair Eisinger called for a recess at 6:23PM

ROADS

SNOW PLOW QUOTES:

No quotes were received. Resident and prospective vendor, Darryl Waletzko was present. The Board spoke with him about the potential of having him quote the work. Chair Eisinger noted that another vendor may be interested in plowing half of the township, in the case that Darryl doesn't have the equipment and/or personnel to take care of the whole township. Darryl was given a copy of the RFQ and stated that he would put some numbers together for consideration at the September meeting.

<u>ROAD ENGINEER:</u> Mike addressed the Board in regard to the crack filling. He noted that all of the usual vendors are still backlogged, due to the severity of the winter and the very wet spring and that quotes are running up to twice the normal

amount, because of those reasons. He suggested that the Board wait until September to call for bids with a completion date of the end of October – beginning of November. Chair Eisinger felt that calling out for bids in October for the 2015 season may be a better option.

The Board tabled this for further discussion at the September meeting.

The pavement management plan still on schedule to have the final product available to the Board in October.

<u>ROAD AUTHORITY</u>: Supervisor Gotzian reported that there are areas that are in need of trimming and clearing of brush and tree limbs in the ROW. Specifically on 268th Ave. NW, north of CSAH4 and east of CSAH1. As well as 147th Ave. NW. The Board is requesting two(2) quotes be found to cut, clear and haul away branches/brush in these areas. They wish to have them available, for review and award at the September 2014 meeting. Darryl Waletzko stated that he would submit a quote, for that work.

He noted that residents at 16301 and $16345 - 258^{th}$ Ave. NW, have placed boulders around the culvert, at the end of their driveways. Letters will be sent to these residents, asking them to remove the boulders. A patch of the pavement needs to be made on 160^{th} St. NW, there is shouldering on 162^{nd} St. NW/255th Ave. NW and 162^{nd}

Darryl Waletzko addressed the Board making them aware of a vendor who has very clean and sticky reclaimed bituminous, which is quite reasonably priced.

There is also some undermining of 253rd Ave. NW and 180th St. NW that needs to be monitored.
