The Orrock Township Board met for the Board of Canvass Meeting, on Thursday, November 16, 2022, at 6pm at the Orrock Town Hall, 26401 – 180th St. NW, Big Lake, Minnesota.

In attendance were Chair Bryan Adams, Supervisors Janine Arnold, Paul Ellinger, Gregg Felber, Bob Hassett and Clerk Chris Weber.

A quorum was present, the meeting was called to order by Chair Adams, at 6:07PM and the Pledge of Allegiance to the United States of America was recited.

Meeting Agenda Approval

Motion/Second to accept the Board of Canvass Meeting agenda by: Ellinger/Hassett. In favor: Adams, Arnold, Ellinger, Felber and Hassett. Opposed: none. Abstained: None.

Motion prevailed, and the meeting proceeded in accordance with the presented agenda.

Board of Canvass

a) Administration of Oath – Clerk

Clerk Weber administered the Canvassing Board Oath of Office to the board of supervisors.

b) Presentation of Township Election Results – Clerk

Clerk Weber presented the Statement of Votes Cast for all contests in Orrock township along with the write-in tally sheet. The board will be canvassing the Orrock Township portion of the votes. There were 245 absentee ballots that were cast in Orrock Township. There were 1,789 total ballots cast in Orrock Township out of 2,654 registered voters - a 67% turnout. There were 2,590 registered voters at 7am on Election Day and 64 persons registered on Election Day.

Town Supervisor Seat A had 14 write-in votes and Bryan Adams received 1,167 votes.

Town Supervisor Seat B had 10 write-in votes. Anne Felber received 857 votes and Bob Hassett received 609 votes.

Town Supervisor Seat D had 12 write-in votes. Gary Goldsmith received 672 votes and Darwin Kostrzewski received 628 votes

Town Supervisor Seat E had 11 write-in votes and Paul Ellinger received 1,148 votes.

Town Treasurer position had 7 write-in votes and Janine Arnold received 1,172 votes.

c) Certification of Township Election Results (Action)

Clerk Weber presented the Certification of Township Election results to the Township Canvassing Board.

Motion/Second to Certify the Election Results by: Felber/Hassett. In favor: Adams, Arnold, Ellinger, Felber and Hassett. Opposed: none. Abstained: None. Motion Prevailed.
