

Board of Canvass Wednesday, November 13, 2024 6:00PM

The Orrock Township Board met for the Board of Canvass Meeting, on Wednesday, November 13, 2024, at 6pm at the Orrock Town Hall, 26401 – 180th St. NW, Big Lake, Minnesota.

In attendance were Chair Bryan Adams, Supervisors Paul Ellinger and Anne Felber and Clerk Chris Weber. Also present was one audience member.

A quorum was present, the meeting was called to order by Chair Adams, at 6:00PM and the Pledge of Allegiance to the United States of America was recited.

### <u>Administration of Oath – Clerk</u>

Clerk Weber administered the Canvassing Board Oath of Office to the board of supervisors.

## <u>Presentation of Township Election Results – Clerk</u>

Clerk Weber presented the Statement of Votes Cast for all contests in Orrock township along with the write-in tally sheet. The board will be canvassing the Orrock Township portion of the votes. There were 1,747 in-person ballots and 698 absentee ballots that were cast in Orrock Township. There were 2,445 total ballots cast in Orrock Township out of 2,841 registered voters - an 86% turnout. There were 2,662 registered voters at 7am on Election Day and 179 persons registered on Election Day.

Town Supervisor Seat C had 17 write-in votes. and Dalton Keiderling received 1,558 votes

Town Supervisor Seat D had 9 write-in votes. Peter Owen received 888 votes and Gary Goldsmith received 800 votes.

Town Clerk position had 8 write-in votes and Shelley Erickson received 1,507 votes.
