### **Thomas Crosby**

B. abt 1575 (Holme On Spaulding Moor England)

D. May 6, 1661 (Rowley MA)

Married Jane Sotheron on October 19, 1600 in Spaulding Moor England

Children: Anthony, Thomas, William, Simon

NOTE: Upon the death of Anthony in 1599, "Thomas inherited a 100-acre farm in Holme-on-Spaulding-Moor. Jane Southeron was the daughter of William and Constance (Lambert) Southern. Sotheron. 1609 tax records indicate that William Sotheron was the wealthiest resident of the parish. Tax records and other documents suggest that the family led a fairly well-to-do life." Relatively late in life, Thomas and Jane emigrated to New England, possibly in the autumn of 1638 with a group of Reverend Ezekiel Rogers' followers, but in any event prior to 1640. They may have lived with the widow of their son Simon in Cambridge, Massachusetts (who died in his 30s) until she remarried in 1645 -- at about that time, Thomas purchased a house in Cambridge. After a few years, he sold his holdings in Cambridge and the couple relocated, for the last time, to Rowley, Massachusetts. Thomas lived to over 85 years of age and died in Rowley in 1661, buried on May 6. Jane died the following year and was buried in Rowley on May 2, 1662.

### **Simon Crosby**

NOTE: See book above. SIMON, Cambridge, came in the Susan and Ellen, 1635, aged 26; with w. Ann, 25; and s. Thomas, 8 wks.; freem. 3 Mar. 1636; had Simon, b. Aug. 1637; and Joseph, Feb. 1639; selectman 1636 and 8, d. Sept. 1639. His young wid. m. Rev. William Tompson of Braintree. His est. by sev. mesne conveyances pass. 1707, to Rev. William Brattle, being that partly occup. now by the Brattle home.

In the Cambridge land inventory on 10 October 1635 "Anthony Couldby" held five parcels of land: one house with backside, about three acres, in the West End; one house with planting ground, about three acres, in West End Field; three acres by the Pine Swamp; four acres in the Neck of Land; and four acres in the Great Marsh; at least one of these lots, and perhaps more, purchased by Simon Crosby.

In April 1635, the family embarked on a journey to New England. Evidence suggests that their move was motivated by religious (rather than taxation) concerns. They joined a company of followers of Reverend Thomas Shephard who were leaving their roots in Essex, Yorkshire and Northumberland to establish a new home in America. They set sail on the "Susan and Ellen" from London on April 18, 1635 and concluded the ten-week trans-Atlantic journey ended in Boston in July 1635.

The group settled in Cambridge, Massachusetts which had been established three years earlier by followers of Reverend Thomas Hooker who were now moving on to Connecticut. Having ample means, apparently through the generosity of his father, Simon purchased a homestead from William Spencer.

Simon and Anne had two more children: Simon Crosby, born in August 1637, and Joseph Crosby, born in February 1637/38.

Simon held a number of public offices including selectman, constable and surveyor of highways.

Simon died in Cambridge in September 1639, aged about 30 years and leaving a considerable estate. It is believed that Reverend Shephard probably conducted the funeral services.

Anne continued to raise her children in Cambridge for another six years and then married Reverend William Tompson, a widower, and moved to Braintree, Massachusetts where Tompson was minister. The couple had one child of their own, Anne Tompson.

In Reverend Tompson's later years, he was "afflicted with melancholia" and did not work for seven years prior to his death in 1666. His disability left his widow in difficult financial circumstances.

Anne died on October 11, 1675 in Braintree at about age 69.
