Every Vendor space touches the pavement. Limited Electricity is available and some spaces have no power connection. Extension cords are not provided. Vendor Coordinator will assign plug-in locations. Power is on a first come first serve basis. Your sales area, tent, booth or trailer must fit inside the 10' road frontage by 20+' depth. If you have a trailer that serves out of the side, and you want to face the road, you must rent enough spaces to fully contain your trailer or sales area. Menus with prices must be posted. No exceptions will be made.

1. All participants must agree to comply with the established Spring Mountain Festival Rules. The rules are posted at www.gowv.com or you may contact the Chamber of Commerce at 304-267-2722 for a copy. Applications, pictures, and entry fees must be received at the Chamber of Commerce no later than April 14. PAY-AT-THE-GATE is not allowed and there is NO RAIN DATE for this event. Entry fees are NON-REFUNDABLE after April 14.
2. It is further agreed, the City of Petersburg, the Grant County Chamber of Commerce and the Grant County Parks and Recreation Department will be held harmless from any liability for damage, loss, or theft of any property used during the festival.
3. Food Handler's license information must be requested from the Grant County Health Department at 304-267-4922. YOU MUST OBTAIN CERTIFICATION PRIOR TO APRIL 11 to participate in the festival.
