# SPBDL EAST & WEST

- **League Mission Statement:** To reintegrate the East & West Area Dart Bar Sponsors & Members into a once again larger league. The emphasis is to promote membership growth not only for sustainability but to create a greater level of competition. This not only allows for in league player growth but to compete amongst other leagues in the state. Integration of the East & West Divisions and growing overall league membership professionally, ethically and with fun sportsmanship will have a lasting impact, generating increased value for current and future league sponsors.
- **League History:** The South Palm Beach Dart League (SPBDL) is a steel tip dart league founded in the 1990's by local dart enthusiasts and at one point has had a membership of over 150 current players with dozens of sponsoring Bars/Pubs. SPBDL is sanctioned by the Florida Dart Association and competes annually in the Florida State Team Championships. The SPBDL covers the south palm beach area of Florida and plays a semiannual league schedule, sponsored by our great local bars/pubs throughout Boca Raton, the edges of its surrounding areas. Operating as a "Not for Profit" league (see attached 2023 FI Sunbiz Annual report), all sponsorship fees collected are used to cover operating expenses in coordinating the league including end of season trophy & awards banquet. The SPBDL operates as a unisex league with multiple divisions comprised of different levels of play. Our members and sponsoring bars also operate weekly Blind draw tournaments and travel together to other FDA sanctioned tournaments throughout the year. Our league is a good old-fashioned fun and friendly way to meet new people and to enjoy a competitive night out.
- **Organizational Structure:** From the beginning we have been operating with (7) board positions. By integrating the East and West areas, we'd look to either add west members to the current board structure and positions or increase the total number of board positions. At the same time, we'd look to reevaluating current position responsibilities to meet the needs of 2023/2024, e.g., social media, dartconnect, etc. The current league rules and by-laws can also look to be reviewed with West membership input and amend where applicable.
- **League Season/Play Format:** Open for discussion. Similarly, we have a 20-week season with 10 Teams. Suggestions:
  - East vs East & West vs West Divisions. A Division & Gold.
  - Same as above with A Division but Gold teams mixing games for the increased competition.
  - # of matches/night and games format: TBD pending division structures

# SPBDL EAST & WEST

- Additional B division: TBD/open for discussion
  - Different night (Thursdays), shorter sch, less games, lower min player requirements, lower cost to Bar sponsors. Goals are to backfill & grow player membership (bring in newbies), and bring addition revenue to Bar Sponsors
- Bring in Dartconnect to manage games and stats:
  - 1<sup>st</sup> season just schedule and standings, 2<sup>nd</sup> season roll out stats tracking
  - Tablet requirements open for discussion
- In Season Bye Weeks: To run rotating blind draws where all players are able to come together during the season.
- End of Season Trophy Banquet:
  - Rotates east to west or East does winter/West Summer Season or vice versa. Again, open to discussion.
  - Trophy's: Order new based on divisions and reintegrated league. Discuss top Allstars, 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>, high outs, etc
- **State Team:** All West Players Eligible. Must be currently on a roster having played the prior season in accordance with current league rules/by-laws.
  - If needed, the tryout venue can rotate at "able to accommodate" East & West Locations.
  - All Sponsors, current and in prior league years who chose to sponsor, will be supported by the State Team, e.g., having scheduled practices at each location.
- **Sponsor Fee Schedule:** Current Bar/Sponsor Fees are \$335.00 per team/season. As a Not-for-Profit Organization, all monies are kept in a business account (Chase Bank), with only a treasurer and one additional Board member having access to the account. Fees are used to operate the league and currently as follows:
  - Annual FI State Sunbiz & FDA membership fees
  - Half the state team shirts
  - Misc fees: Storage of portable boards, bank fees, website/domain
  - Trophy/awards, including raffles giveaways to players & Banquet cost
- New Season packet pickup (league sponsored blind draw \$\$)
