The purpose of bi-lateral modification P00006 to contract W52P1J-18-D-A041 is to accomplish the following:

1. Exercise Ordering Period (OP)2, OP3, and OP4 under the authority of Federal Acquisition Regulation (FAR) 52.217-9, Option to Extend the Term of the Contract under contract W52P1J-18-D-A041 for the following Periods of Performance (POP):

- OP2: 25 September 2024 - 24 September 2025
- OP3: 25 September 2025 - 24 September 2026
- OP4: 25 September 2026 - 24 September 2027

Note: All ordering periods were evaluated at the time of the original contract award.

2. The Government is issuing the modification to exercise OP2, OP3, and OP4 for bilateral signature but reserves the right to sign the modification unilaterally. If no response is received to the request for signature on this modification by 1700 CST on 10 Sept 2024, the Government will move forward with unilateral signature on 11 Sept 2024.

3. This modification also incorporates the addition and removal of the following mandatory FAR and DFARS Property Clauses:

Government Property Clause Additions

- a. DFARS 252.2457005, Management and Reporting of Government Property
- b. FAR 52.245-1, Government Property
- c. FAR 52.245-9, Use and Charges

Government Property Clause Removals

- a. 252.245-7001 Tagging, Labeling, and Marking of Government-Furnished Property
- b. 252.245-7002 Reporting Loss of Government Property
- c. 252.245-7004 Reporting, Reutilization, and Disposal
- d. 252.211-7007 Reporting of Government-Furnished Property

4. Update FAR Clause 52.216-22. As a result, change available performance after the last exercised ordering period from twelve (12) months to sixty (60) months. This would allow performance to be available up to 24 September 2032 in accordance (IAW) with AFARS 5117.204(e)(iii) and the statutory limitations found at FAR 17.204(e).

- a. Ordering periods remain unchanged and orders will be allowed until 24 September 2027.
- b. Modifying FAR Clause 52.216-22 hereby allows task orders to have unexercised options up until 24 September 2032.

5. As a result of this modification, ITES-3S ceiling rates will not apply to orders placed in OP2 and beyond. In the event ceiling rates are included in task orders awarded prior to this change, with unexercised options, those options are enforceable at those previously awarded rates. This change applies to future task orders only, and shall not result in modification of existing ITES 3S orders.

Ceiling rates will remain on the ITES-3S website for historical purposes. All orders executed after OP2 are hereby allowed to submit pricing at the task order level ITES-3S vendors are no longer required to propose in accordance with its ceiling rates .

- a. By incorporating this change, all future Orders against W52P1J-18-D-A041 will be negotiated or competitive at the task order

I-2 CHANGED 52.216-22 INDEFINITE QUANTITY OCT/1995

(a) This is an indefinite-quantity contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the maximum. The Government shall order at least the quantity of supplies or services designated in the Schedule as the minimum.

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contracts effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after sixty months from contract expiration.
