Meeting Minutes

Meeting Date: July 22, 2021

Type of Meeting: Regular Board Meeting

1. Call to Order

The Joint Powers Water Board meeting was held by remote computer access and teleconference. Chairman Leigh called the meeting to order at 3:02 p.m.

2. Roll Call

A quorum was present with Gene Legerski and Robert Young (RS), Terry Leigh (GR), Hilary Huckfeldt (SW Co) present. Ms. Hunter (GR) was absent. Ms. Sage Hilstad, Council for the Board was in attendance. Staff attending were Bryan Seppie, General Manager, Michael Tardoni, Engineer and Sara Richardson, Office Manager. Randal (Doc) Wendling SW County Commissioner called in.

3. Approval of Agenda

Mr. Legerski made a motion to approve the agenda. Ms. Huckfeldt seconded the motion. The motion was voted on and passed.

4. Approval of the June 9, 2021 Budget Public Hearing Minutes

Mr. Legerski made a motion to approve the June 9, 2021 Budget Public Hearing minutes. Mr. Young seconded the motion. The motion was voted on and passed.

5. Approval of June 9, 2021 Board Meeting Minutes

Mr. Young made a motion to approve the June 9, 2021 Board Meeting minutes. Ms. Huckfeldt seconded the motion. The motion was voted on and passed.

6. Approval of May 2021 Financial Reports

Ms. Huckfeldt made a motion to approve the May 2021 financial reports. Mr. Legerski seconded the motion. The motion was voted on and passed.

7. Water Sales and Usage Reports

Mr. Seppie presented the June 2021 water sales and usage reports stating that June's sales will be the first revenue for the new fiscal year. Usage was up for the month at 520 million gallons, 112% of the 4-year average.

8. Investment Policy and Portfolio Review

Mr. Seppie presented the Board with the financial portfolio with balances through May 2021. This data gives the Board a chance to review the investments and financial planning for the fiscal year. Mr. Seppie stated this review will be conducted annually in July as intended by Resolution.

The 8 CD's that matured in December of 2020 lacked a laddering strategy. The timing of these reinvestments impacted revenues with the lower interest rates being paid currently.

Mr. Seppie reviewed the portfolio showing the funds being held, their rate of returns and how he would like to proceed in the coming year. Mr. Seppie identified the accounts that he intends on liquidating as payments on the Reservoir construction project become due. Additionally, Mr. Seppie identified the three accounts being held at Uinta Bank that are contractually obligated. One being required by the WWDC and the other two being held in the name of the Cities.

Chairman Leigh stated that Mr. Seppie's plan was conceptually good. Ms. Huckfeldt felt this review was very helpful.

9. **Operational and/or Project Updates**

Mr. Seppie had six updates for the Board:

Item 1 being the Raw Water Reservoir; there will be a 90% stage meeting next week where they will be reviewing the project documents and discuss the project's timeline. To accelerate the process, the plans will now be submitted to DEQ and SEO, concurrently a "preliminary plans-not for bid" will be forwarded to an on-line plan service. Mr. Seppie stated that the new director for the Water Development maybe receptive to a time extension request, so he plans to pursue this.

Item 2; Mr. Seppie wanted to make the Board aware of a potential problem with obtaining polymer in the amounts desired. There has been a shortage in one of the key ingredients for the polymer production. The vendor has absorbed two initial price adjustments but has now informed us of a 6% cost increase. There was discussion regarding reaching out to the local industries to see if they could help if the need arose.

Item 3 is the financial audit for FY2021. The auditors will be on site the week of August 9^{th} . Staff has been busy with their early requests.

Item 4 was the Bureau of Reclamations planned releases from Flaming Gorge Reservoir (and two other reservoirs) to elevate water levels in Lake Powell. Mr. Seppie explained to the Board how these releases will affect the upper basin's ten-year running average. These releases are not a surprise, but the timing is earlier than anticipated. The next meeting of the BOR will be held on August 12th Mr. Seppie will send out the information.

Item 5 was a draft letter addressed to Mr. Seppie and the Director of Utilities for the City of Cheyenne from Mr. Chris Brown, who is the Senior Assistant Attorney General over Water and Natural Resources working with the State Engineer. Mr. Seppie's reason for presenting this letter was to open discussions with the Board as to how they would like to be involved with these types of letters of support or advocacies. These can get to be a daunting task and may lead to a precarious position for the Board. The Board advised Mr. Seppie to monitor, use judgement, and previous experience with these requests.

Item 6, Mr. Seppie updated the Board that the DEQ discharge renewal has been received. The plant will operate under the new limits, as previously discussed, the limits are more restrictive. The lowered limits have required changes to the plant's SCADA control strategies. These changes will impact the plant's operation and power usage.

10. **Public Comments**

Commissioner Wendling left the meeting during the Operational/Project Updates. None

11. Good of the Order

Chairman Leigh stated that he had attended the County Commissioners meeting. Representative Stith had presented to them, stating that the State of Wyoming had \$1B coming and that the Board should apply for this. Mr. Seppie stated that the Cities and the County had anticipated these funds and were looking at water and sewer projects. There was discussion regarding the potential funding and the uncertainty with the process.

12. **Executive Session**

Mr. Seppie asked for an executive session to discuss personnel issues.

Mr. Legerski made a motion to move to executive session at 4:03 p.m. Mr. Young seconded the motion. The motion was voted on and passed.

At 4:23 p.m. Mr. Legerski made a motion to reconvene the regular Board meeting. Ms. Huckfeldt seconded the motion. The motion was voted on and passed. No action was taken.

13. **Next Meeting**

August 19, 2021 3:00 p.m.

14. **Adjournment**

There being no further business Chairman Leigh adjourned the meeting at 4:27 p.m.




