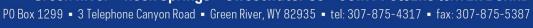

Meeting Minutes

Meeting Date: September 18, 2025

Type of Meeting: Regular Board Meeting

1. Call to Order

The Joint Powers Water Board meeting was held by remote computer access, teleconference, and in the conference room at the Water Treatment Plant. Chairman Young called the meeting to order at 3:02 p.m.

2. Roll Call

A quorum was present with Terry Leigh (SW Co), Jason Palmer (GR), Robert Young and Richard Lee (RS) present. Aaron Reichl (GR) was absent. Ms. Sage Hilstad, Counsel for the Board, was in attendance. Staff attending was Bryan Seppie, General Manager, James Tardoni, Engineer, and Sara Richardson, Office Manager. Mark Westenskow, City of Green River and Alexis Spray were also in attendance.

3. **Approval of Agenda**

Mr. Lee made a motion to approve the agenda. Mr. Leigh seconded the motion. The motion was voted on and passed.

4. Approval of August 20, 2025 Board Meeting Minutes

Mr. Leigh made a motion to approve the August 20, 2025 Regular Board Meeting minutes. Mr. Lee seconded the motion. The motion was voted on and passed.

5. Approval of July 2025 Financial Reports

Mr. Leigh made a motion to approve the July 2025 Financial reports. Mr. Lee seconded the motion. The motion was voted on and passed.

6. **Presentation of August 2025 Water Sales and Usage Reports**

Mr. Seppie presented the August 2025 water sales report saying this was the third month of revenue in this fiscal year. Not only was the revenue higher because of the rate increase, the quantity of sales was also higher. Each of the customers was above the 4-year average and together they are at 105%. This exceeded the forecast for revenues for the first 3 months.

7. Presentation and Consideration of an Annex to the Employee Reference Guide – "Conduct and Code of Ethics"

Mr. Seppie reminded the Board that the Financial Auditors had recommended the Board adopt a code of ethics for its employees. Therefore, an addition to the Employee Reference Guide has been drafted. The language in the annex is straightforward, and verbiage is similar to the local entities personnel policies. Ms. Hilstad reviewed it and had some additions. Mr. Seppie recommended that the Board

approve the annex to the Employee Reference Guide, which is simply a code of ethics and conduct.

There was discussion about whether this was a new policy or an updated one for the employees to follow. Additional discussion about employees' review of the document, and if there are consequences in place if an employee breaks the policies.

Mr. Lee made a motion to approve the Annex to the Employee Reference Guide. Mr. Leigh seconded the motion. The motion was voted on and passed.

8. Presentation and Consideration of an allocation from the FY2025 Surplus of Budget towards Reserves

Mr. Seppie stated that there was discussion at the last Board meeting concerning the surplus from fiscal year 2025 and what, if anything, the Board may want to do with it. The Board had previously discussed applying it to reserves. Mr. Seppie said that the surplus was approximately \$280,000 but suggested that only \$250,000 be reallocated. Mr. Seppie presented the current four reserve accounts that the funds could be placed in. With concern of future water availability, he recommended that the Board reallocate \$250,000 to the Water Resources Reserve.

Mr. Palmer made the motion to reallocate \$250,000 of the FY2025 Budget surplus to the Water Resources Reserve. Mr. Leigh seconded the motion. The motion was voted on and passed.

9. Presentation and Consideration of Resolution 26-01: Official Name and Principal Place of Business.

Mr. Seppie explained that the Board's official name, as identified in the original Joint Powers Agreement, is "City of Green River, Wyoming-City of Rock Springs, Wyoming-Sweetwater County, State of Wyoming Joint Powers Water Board". Over the years, and in various documents, it has often been rearranged and/or shortened. An issue came up during the application process for the DWSRF loan for the Crossroad Pump Station project. The application required a "SAM.gov" Federal ID number. The Federal website will only accept the official name and physical address. Mr. Seppie explained the documents that they would accept to prove the official name and physical address. However, most of the documents have utilized a shorter name and the P.O. Box. Thus, the need for this resolution to state the official name and physical address on one document.

There was discussion about going back to the Secretary of State to correct the issues. Ms. Hilstad had already corrected the certificate from the Secretary of State, however this document does not identify the physical address. Mr. Seppie hopes that this Resolution will be enough to obtain the Federal ID number.

Mr. Lee made a motion to approve Resolution 26-01, Official Name and Place of Business. Mr. Leigh seconded the motion. The motion was voted on and passed.

10. Operational and/or Project Updates

Staff have advertised and interviewed for a relief operator position; the new employee will start on October 6th. Staff have been advertising for the office manager's position, and it is open until September 26th. Staff are hoping to have someone in place in October to ensure they will be able to do a couple of cycles of payroll and water billing prior to Mrs. Richardson's retirement. This overlap will also be an opportunity to enhance the written procedures that are in place. Mr. Seppie asked if the Board would like anyone to assist with the interviews. Chairman Young said he would be able to assist in the interview process, Mr. Leigh would also be available if needed.

The next item Mr. Seppie addressed was the Crossroads Pumpstation Project loan for the DWSRF program. The application will be considered on October 2, 2025, at the SLIB meeting in Cheyenne.

A couple of reminders about this year's CRUWA conference. The registration is open and there is a bigger block of hotel rooms at Ceasars. Please make the reservations yourself and you will be reimbursed. Mr. Seppie will register anyone who would like to attend the conference.

There are a few signatures still needed on a form for the Department of Audit. Please make arrangements with Ms. Richardson to get those done.

There were discussions about the CRUWA and what could be expected.

11. Public Comments

12. Good of the Order

Chairman Young said he appreciated Mr. Seppie keeping him in the loop with the Fontenelle issues.

Mr. Seppie stated that the CRWUA Public Affairs committee has been working on a video for the anniversary of the organization. There is footage from Trout Unlimited showing some of their projects in the Green River Basin. Ironically the film crew was planning to take footage of the Green River Lakes, which would have been prior to fire, but unfortunately the filming didn't take place.

Lastly, Mr. Seppie discussed a tour at Flaming Gorge where he was able to hear from the Utah Department of Natural Resources and their concerns about drought and upcoming releases.

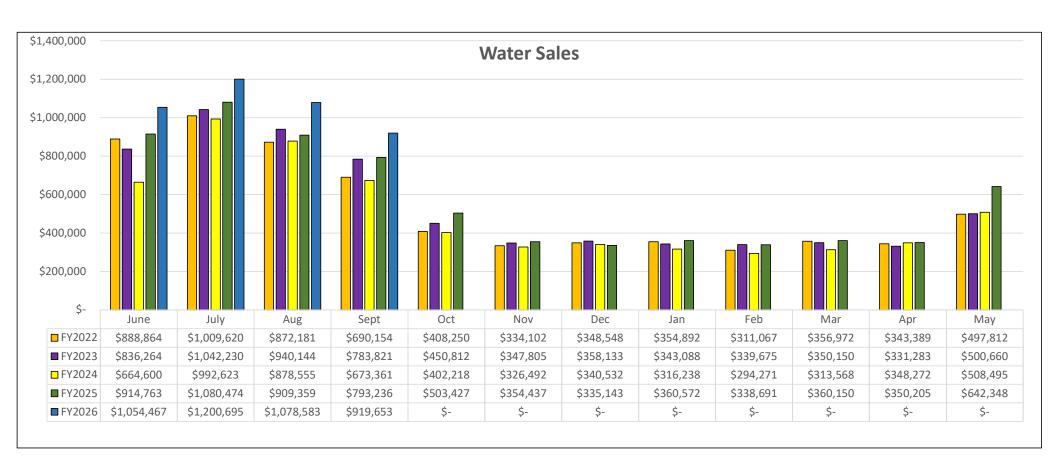
