## **Great Lakes Womens Shelter Workplace Giving Program**

What is Workplace Giving?

It is an easy and affordable way for you yo support GLWS by making a regular donation direct from your pay?

Workplace Giving, (WPG), also known as Payroll Giving, enables employees to make a PRE TAX donation to a Charity of their choice direct from their wages every payday.

Employees arrange with their Employer to make regular deductions from their pay: From as little as \$1 per week.

The Australian Tax Office allows donations such as these to be deducted before tax.

Because of this Tax Concession employees receive the tax benefit UPFRONT each payday, and consequently they actually save tax while supporting the Shelter.

The introduction of Workplace Giving will bring about a long-term joint relationship between employers, employees and Great Lakes Womens Shelter Inc.



A Pre-Tax donation of just \$20.00 per fortnight = \$520.00 per year.

For example:

If you were to donate \$20.00 each fortnight, it will actually only cost you approximately \$13.50\* because you won't pay tax on the amount you donate to the Shelter. – But the Shelter will still receive the full \$20.00 donation.

In many cases, employers will match staff donations, so the value of your donation will double to \$40 direct to Great Lakes Womens Shelter
