Great Lakes Womens Shelter Workplace Giving Program

What is Workplace Giving?

It is an easy and affordable way for you to support GLWS by making a regular donation direct from your salary.

Workplace Giving, (WPG), also known as Payroll Giving, enables employees to make a PRE-TAX donation to a Charity of their choice direct from their wages every payday.

Employees arrange with their Employer to make regular deductions from their pay: from as little as \$2 per week.

The Australian Tax Office allows donations such as these to be deducted before tax.

Because of this Tax Concession employees receive the tax benefit UPFRONT each payday, and consequently they actually save tax while supporting the Shelter.

Workplace Giving creates a long-term meaningful relationship between employers, employees and Great Lakes Womens Shelter Inc.

**A Pre-Tax donation of just
\$20 each fortnight
= \$520 per year.**

For example:

If you were to donate \$20 each fortnight, it will only cost you around \$13.50 because you won't pay tax on the amount you donate, but the Shelter will still receive the full \$20 donation.

In many cases, employers will match staff donations, so the value of your donation could double to \$40.
