New Project Reviews:

A. Request for a Rezoning and Development Order Approval on 5105 Leonard Blvd, Lehigh Acres FL. The applicant is requesting a Rezoning from RM-2 to CF and a Development Order Approval to develop a Lehigh Acres Fire Station 107. Project is presented by Jason White w/ Exceptional Engineering.

Jason White with Exceptional Engineering presenting: This is the Fire Station 107. It is like the other new fire station with the execption that it will have two more bays. There will be a Fire Tower that will be at the top 50 feet tall. The is discussion about what the fire tower will look like and this is what they would like (picture shown). They are starting with the training facility. First, they need a clear and fill permit. And when the funding becomes available, then the training pad first. Followed by Station 108 and the training back buildings.

Board Member Comments:

Laurie -1) The extra two bays, is it for storage or for the use of the community? Response to Laurie -1) Right now for storage. But nothing is set in stone.

Mohamed -1) It is critical for us to have a training center. I have a concern about the two more bay when there are two other fire stations around. 2) Two bays to put in place and when they are in times of need. Maybe a shelter. Are we planning on putting a light there?

Response to Mohomed -2) if that affects the timing, they might put a light there. (Derek mentioned that the County is looking at putting a round-a-bout there)

Inke – 1) why two more bays? 2) what about the large concert pad? And the foam and chemicals? 3) do they recycled the shipping containers 4) what about lighting? 5) What about control burns? Will they be informing the public? 6) How is the area securited?

Response to Inke - 1) With the training being held there, they will be storing one more fire truck and ambulance depending on funding. 2) they will still have to follow EPA guidelines. 3) the shipping containers hold up very well. 4) there will be lighting for the fire station only. No floor lighting. We are not required to have all the guidelines, but there will be not lighting for the training area? 5) I would think that there would be some way to let them know about the burns. One of the Chief's big things is that they are congunious of the neighbors. The Chief is big on keeping towards the park. 6) There will be a fence and the parking lot for employees will be fenced. And there will be security cameras. But I don't know what else they will be using.

Derek -1) Why 5 stories on the fire tower? 2) Would it be for Lehigh or would other departments use it as well? 3) Will they be using the lake for training? 4) Is it used as dry storage? 5) Wouldn't it be better and use the fill? 6)Where is the offside? 7) Will they be training on city water? 8) Would they be using the water from Town Lakes?

Response to Derek – 1) They looked at eight training towers and they like this one the model the best. The one on Daniels is the same height. 2) I believe that it would be for just the fire department. Not the sheriff's. They do right now visit other fire departments but this is just for Lehigh. It is needs. They were going to building one at the new 102 but then this property became available. 3) They could. There are many different methods they can use. One is where they have a concert pond then they can use that for drafting. 4) Yes, but they are still discussing options. 5) LAMSID is providing the fill. 6) it will be the same as the park with a dry retention system. 7) They are talking about a well because city water is expensive. They thought about the pit and using well and city water. 8) no.

Wade -1) You have not submitted a permit yet.

Response to Wade -1) We are looking at the zoning approval in one month. Then the Clear and fill when we would come to LASMID. They are hoping to start 107 and have it open in 2024.

Public Comment:

Vicky – 1) What about a traffic light there? 2) and will they be pulling out of Town Lakes?

Response to Vicky – 1) There is no talks about a traffic light, but it will depend on if it effects response times. 2) Chief was hesitant to use the water from Town Lakes Lake. We would build our own lake.
