ORDINANCE NO. 9 - 2025

AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF MADISON VILLAGE, OHIO, SECTION 131.08(C), TO INCREASE COMPENSATION PAYABLE TO THE LAW DIRECTOR.

WHEREAS, § 131.08(C) of the Codified Ordinances establishes salary compensation for the Law Director, which was last adjusted by Ordinance No. 19-2023; and

WHEREAS, in accordance with the recommendation of the Mayor, the Council desires to adjust the salaried compensation for the Law Director.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE, STATE OF OHIO, THAT:

- SECTION 1. That § 131.08(C) of the Codified Ordinances of Madison Village, Ohio is hereby amended to increase the annual salary compensation of the Law Director from \$33,000.00 to \$38,000.00, which increase is and shall be effective as of March 9, 2025, as follows with all text of current division (C) to be stricken and revised shown with a strike-through (to wit: abcd) and new text shown in underline (to wit: abcd):
 - (C) Law Director: \$33,000.00 \$38,000.00 annual salary, payable bi-weekly, for all Charter and statutory duties. In addition, \$150.00 per hour for civil litigation and criminal prosecutions involving a jury trial, payable monthly upon invoice. The Law Director's position shall be classified as "salaried, part-time" employee.
- SECTION 2. This Ordinance shall be published in book form with the certifications of the President of Council and Fiscal Officer of the correctness of this revision to § 131.08(C).
- SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including § 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance shall take effect at the earliest time provided by law.

ORDINANCE NO. 10-2025

AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR TO ENTER INTO A RENEWAL OF THE INTERGOVERNMENTAL CONTRACT WITH THE PUBLIC ENTITIES POOL OF OHIO JOINT SELF-INSURANCE POOL; AND DECLARING AN EMERGENCY

WHEREAS, the Public Entities Pool of Ohio is an inter-governmental self-insurance pool which provides for the pooling of financial and administrative resources for Ohio political subdivisions to afford self-insurance protection upon favorable terms and conditions for its members; and

WHEREAS, by Ordinance No. 12 - 2023, the Village entered into a contract with the Public Entities Pool of Ohio; and

WHEREAS, submitted to the Village and on file with the Fiscal Officer is a current summary of the property, liability, and extended coverages for the Village as a pool member for the term commencing April 4, 2025; and

WHEREAS, the Village's estimated 2025 term annual pool contribution for these coverages is Forty-Seven Thousand Two Hundred Six Dollars and No Cents (\$47,206.00); and

WHEREAS, upon the recommendation of the Mayor and Fiscal Officer, the Council has determined that it is in the best interests of the Village to continue membership in the intergovernmental agreement with the Public Entities Pool of Ohio for pooled self-insurance coverage.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF MADISON VILLAGE, COUNTY OF LAKE, STATE OF OHIO:

<u>SECTION 1</u>. That the contract with the Public Entities Pool of Ohio is hereby approved for renewal and the Mayor and Fiscal Officer be and are hereby authorized and directed to execute any such renewal agreements on behalf of the Village for a one-year term, to be effective from April 4, 2025, and for the contribution sum of Forty-Seven Thousand Two Hundred Six Dollars and No Cents (\$47,206.00), be the same more or less, but not to exceed the amount of funds appropriated in the current calendar year for Village insurance coverage.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including § 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety of the inhabitants of this Village, and for the further reason that insurance coverage must be entered into forthwith so as to provide continuous insurance protection against claims, casualty or other losses; wherefore, this Ordinance shall take effect and be in force from and immediately upon its passage.
