#### ADMINISTRATOR'S REPORT:

#### > Engineer's report -

Mr. Haibach reported that he is in the process of closing out last year's road program which was Parkway Boulevard and Park Oval. Mr. Haibach explained the reason it was not closed out earlier was due to drainage issues on Park Oval

in the cul de sac. Just a few weeks ago, the contractor came out and fixed the issue. Now that the issue is fixed, he will release the retainage to the contractor, Cole Burton.

He reported that in regards to this year's road program, the Village has received OPCW funding for paving the north end of Appaloosa Trail and a short section of Dawn Road. His engineer's estimate for the total project cost was around \$237,000.00. The Village asked OPCW to split this cost. They agreed to give us a grant in the max amount of \$68,800.00 and up to a \$50,000.00 loan with zero interest for twenty (20) years.

He will provide an update with the bid advertisement date.

A brief discussion took place regarding the road conditions on W. Parkway Drive.

Mr. Haibach stated that he will be submitting a grant application for the Safe Streets and Roads for All (SS4A) to try and secure funding for the sidewalks on Middle Ridge Road. With this being a street and roads grant, he is not sure how competitive Madison Village will be with this, however; he is still going to try. He thanked those that are working on the decommissioning of the Waste Water Treatment Plant (WWTP). He stated that they are ahead of schedule at this point. Councilman Lee commented on the progress going on at I-90. He stated that they are not keeping with their timeline they provided for the opening and closing of the on/off ramps. Mr. Haibach stated that this is an O.D.O.T. project. Chief McIntosh stated that the eastbound entrance is going to be delayed another week.

#### Fiscal Officer's report –

Mrs. Crockett reported that she has been working on the tax budget. In regards to the street lighting ordinance, she stated that she is reducing the millage due to having a surplus in this fund. She stated that she is going to reduce it to one (1) mill and keep a close eye on the account and re-evaluate it annually.

Mr. Vest stated that the Village is still going to switch over to LED lighting. Mrs. Crockett stated that even with the annual street light electricity bill that the Village receives plus the one (1) mill that the Village will receive for next year's collection there will still be enough money to take care of this. She stated that next May when it is time to prepare the street lighting legislation she will reevaluate the balance in the fund. She stated that if the millage needs increased next year, it will be done through legislation and voted on by Council.

#### Police Chief's report –

Chief McIntosh reported that another successful Safety Town concluded last week. Fifty-eight (58) students (ages 3 – 6 years old) graduated for the program. He thanked the Madison Village Officers, Madison Township Police Department, Lake County Sheriff's Department, Perry Village Police Department, Painesville Municipal Court as well as two (2) Troopers from the Ohio State Patrol for participating in Law Enforcement Day.

Councilman Adams stated that one of his grandchildren attended and he was very impressed with how things ran how wonderful the program is.

In regards to training, the first fire arms qualification and range are coming up later in the week.

He provided a quick update in regards to the on/exit ramps at I-90. He reported that the department is starting a new program that can help caregivers for residents with cognitive issues, dementia or other impairments enter descriptive information about that person. This can help first responders locate the person should they go missing or have an emergency. The caregivers can access this through the MVPD website in order to give first responders information about the residents. This program would allow only Madison Village Officers to access the information. The program is currently on their website, however; they are going to do more testing before they start promoting it.

In closing, he reminded all that with the holiday weekend coming up that fireworks are not permitted to be discharged in the Village.

#### Administrator's report –

Mr. Chapman left a report due to his absence. He asked Mrs. Crockett to provide his update which is as follows:

The decommissioning of the WWTP is going well. He estimates that as of this point, approximately 55% of the entire decommission is complete. He thanked the Madison Village Service Department with their help on this project. In regards to the Madison Village Outdoor Market and Concerts in the Park, there are forty-five (45) vendors signed up and attending. The crowds have been large and well attended. He thanked Mrs. Grafton for her work with these events. The second letters have gone out to the residents in regards to the change in garbage collectors.

He wanted to thank Mrs. Crockett, Mr. Donaldson and Ms. Drown for willingness to attend the meeting to be held at the County regarding the Senior Center.

Health Markets held their re-grand opening. He thanked Mayor Britton, Ms. Drown, Mrs. Grafton and Chief McIntosh for joining him in attending the event.

#### **COMMISSION AND COMMITTEE REPORTS:**

Councilman Adams reported that there was a Fire Board Meeting on June 18, 2025. At that meeting University Hospital had a great presentation for some of the firefighters that provided life saving assistance to a victim at the local Urgent Care. The firefighters were recognized for their amazing efforts. The victim was in attendance and was able to thank the firefighters that saved her life. Channel 8 news was there broadcasting the event.

The July 16, 2025 Fire Board meeting will be held at Station 2.

AN ORDINANCE PROVIDING FOR ADDITIONAL PERMANENT APPROPRIATIONS AND ADJUSTMENTS TO VARIOUS LINE ITEMS FOR THE CURRENT EXPENSES AND FOR OTHER EXPENDITURES OF THE VILLAGE OF MADISON, OHIO, FOR THE PERIOD BEGINNING JANUARY 1, 2025 TO AND INCLUDING DECEMBER 31, 2025, AND DECLARING AN EMERGENCY.

WHEREAS, the Fiscal Officer requests this Council to authorize additional permanent appropriations and adjustments to various line items for current expenses and for other expenditures of the Village during the year 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE AND STATE OF OHIO, THAT:

SECTION 1. To provide for current expenses and other expenditures of the Village of Madison, Ohio, for the period beginning January 1, 2025, to and including December 31, 2025 there be and hereby is appropriated the following amounts:

\$40,000.00		From: Unappropriated General Fund (1000)
	\$20,000.00	To: Salaries/Administrator 1000-710-131-0000 (Administrator)
	\$20,000.00	To: Personal Services/Salaries

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village of Madison, and further necessary to provide the Village of Madison the necessary funds for the operation of the Village during the period aforesaid; wherefore, this Ordinance shall take effect and be in force immediately upon its passage.

#### **ORDINANCE NO. 17 - 2025**

AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF MADISON VILLAGE, OHIO, PART SEVEN - PLANNING AND ZONING, SECTION 17.5, APPENDIX A, TO ADJUST THE ZONING CODE FEE SCHEDULE TO REFLECT INCREASES IN ADMINISTRATIVE COSTS.

WHEREAS, the Administration has reveiwed the labor time, costs, and expenses to the Village in processing permits pursuant to the Zoning Code; and

WHEREAS, upon review, the Adminstration finds that current fees for certain of the permit processing labor time, costs, and expenses are significantly less than actual costs to the Village; and

WHEREAS, the Administration has proposed a revised Appendix A to § 17.5 of the Zoning Code to increase certain fees to better recapture the actual administrative costs; and

WHEREAS, upon consideration of the recommendation made by the Administration and having given the matter its independent consideration, the Council finds that it is in the public interest, health and welfare, and consistent with actual administrative cost and expenses to amend Appendix A to § 17.5 of the Zoning Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE, STATE OF OHIO, THAT:

SECTION 1. That the Codified Ordinances of Madison Village, Ohio, Part Seven - Planning and Zoning, as enacted by Ordinance No. 30-2013, as amended, is and shall hereby be amended with revised Addendix A (and as Appendix A is incorporated in the Zoning Code by § 17.5), said amendment appearing in Exhibit "1" attached hereto and incorporated herein by this reference as if fully re-written wherein current text which is stricken by this Ordinance appears with a strike-through line (to wit: abed) and new text added to Appendix A by this Ordinance appears as underlined text (to wit: abcd).

<u>SECTION 2</u>. That publication of this revised Appendix A shall occur in book form containing the certification of the President of Council and Fiscal Officer of its correctness.

<u>SECTION 3</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including § 121.22 of the Ohio Revised Code.

#### **ORDINANCE NO. 18-2025**

## AN ORDINANCE DETERMINING TO PROCEED WITH THE IMPROVEMENT OF ALL DULY DEDICATED STREETS WITHIN THE VILLAGE OF MADISON WITH ELECTRIC STREET LIGHTING AND APPURTENANCES THERETO, AND DECLARING AN EMERGENCY

WHEREAS, this Council, pursuant to Resolution 6-2025, adopted June 23, 2025 declared the necessity for improving all duly dedicated streets within the Village of Madison with electric street lighting and appurtenances thereto; and

WHEREAS, the Fiscal Officer has prepared and filed an estimate of cost for the year 2025 for improving all duly dedicated streets by supplying the same with electric street lighting and appurtenances thereto; and,

WHEREAS, the legislative authority has determined to proceed with said improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE, STATE OF OHIO, THAT:

<u>SECTION 1</u>. That it is hereby determined to proceed with the improvement in the Village of Madison, Lake County, Ohio, of all duly dedicated streets within the Village by supplying the same with electric street lighting and appurtenances thereto which this Council declared to be conducive to the public health, convenience and welfare.

<u>SECTION 2</u>. That said improvement shall be made in accordance with the provisions of Resolution No. 6-2025 adopted June 23, 2025, and with the plans, specifications and estimates of the proposed improvement heretofore approved and now on file in the office of the Fiscal Officer.

SECTION 3. That all claims for damages resulting there from that may have been legally filed shall be inquired into after completion of the proposed improvement and the Village Law Director is hereby authorized and directed to institute legal proceedings in a court of competent jurisdiction to inquire into said claims that have been so filed.

<u>SECTION 4</u>. That portion of the cost provided in the above-mentioned Resolution of Necessity shall be assessed in the manner provided in said Resolution on the lots and lands described therein.

<u>SECTION 5.</u> That the estimated assessments heretofore prepared and filed in the office of the Fiscal Officer be and the same are hereby adopted.

<u>SECTION 6.</u> That the Fiscal Officer is hereby directed to deliver a certified copy of this Ordinance to the Lake County Auditor upon its passage

SECTION 7. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that, except as otherwise provided by Section 121.22 of the Ohio Revised Code, all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 8. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety of the inhabitants of this Village, and for the further reason that the Village is without funds to provide electric street lighting and appurtenances thereto and the same is necessary for the protection of pedestrians and vehicular traffic in the Village; WHEREFORE, this Ordinance shall take effect and be in force from and immediately upon its passage and signature by the Mayor.

#### **ORDINANCE NO. 19-2025**

# AN ORDINANCE LEVYING ASSESSMENTS FOR THE IMPROVEMENT OF STREETS IN THE VILLAGE OF MADISON, OHIO BY SUPPLYING SAME WITH ELECTRIC STREET LIGHTING AND APPURTENANCES THERETO, AND DECLARING AN EMERGENCY

WHEREAS, tenative assessments showing the amount to be assessed on each lot and parcel of land in the Village of Madison for improving the duly dedicated streets of said Village by supplying the same with electric street lighting and appurtneances thereto have been prepared and have been on file in the office of the Fiscal Officer; and

WHEREAS, notice of the making and filing of said tentative assessments has been duly published and personally served according to the provisions of law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE, STATE OF OHIO, THAT:

SECTION 1. Notice of the making and filing with the Fiscal Officer of the assessments for the cost and expense of improving all of the duly dedicates streets in the Village of Madison with electric street lighting and appurtenances thereto has been duly published in accordance with law and that the Council of the Village of Madison hereby adopts and confirms said assessments and the several amounts thereof aggregating in the estimated amount of \$110,266.29 and will be for the tax year 2025 collected in 2026.

SECTION 2. There be levied and assessed upon all of the lots and lands in the Village of Madison, Ohio as enumerated in the tentative assessments, which said lots and lands are specially benefitted by said improvement, the several amounts heretofore reported to Council by the Fiscal Officer and as described in Resolution 6-2025 marked Exhibit "A" and incorporated in this Ordinance and for which assessments and the several amounts thereof amount to 1 mill for each one dollar of valuation which is 10 cents for each one hundred dollars of valuation of the property assessed.

SECTION 3. That the total assessment against each lot and parcel of land shall be payable in cash to the Fiscal Officer of the Village of Madison within thirty (30) days after the passage of this Ordinance, and if not paid in cash within such period shall be certified to the County Auditor for collection with the general taxes and collected against each of the lots or parcels of land so assessed.

<u>SECTION 4</u>. The remainder of the entire cost of said improvement shall be paid out of the General Fund of the Village of Madison.

SECTION 5. The assessments charged against each lot or parcel of land shall be certified by the Fiscal Officer to the Auditor of Lake County, Ohio, as provided by law, to be placed by him upon the tax duplicate and collected as other taxes.

<u>SECTION 6.</u> The Fiscal Officer shall cause notice of the passage of this Ordinance to be published twice in a newspaper of general circulation and shall keep said assessments on file in his office.

<u>SECTION 7.</u> The Fiscal Officer is hereby directed to deliver a certified copy of this Ordinance to the Auditor of Lake County, Ohio.

SECTION 8. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 9. This Ordinance is hereby declared to be and is passed as an emergency measure, the measure being that the Village is without sufficient funds to provide electric street lighting and appurtenances thereto; and, therefore, this Ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare and shall take effect and be in force immediately upon its passage and signature of the Mayor.

#### RESOLUTION NO. 6-2025

A RESOLUTION DECLARING THE NECESSITY TO IMPROVE CERTAIN STREETS IN THE VILLAGE OF MADISON, OHIO BY SUPPLYING SAME WITH ELECTRIC STREET LIGHTING AND APPURTENANCES THERETO, AND DECLARING AN EMERGENCY.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE AND STATE OF OHIO, THAT:

SECTION 1. It is necessary to improve all duly dedicated streets within the appropriate limits of the Village of Madison, Ohio with electric street lighting and appurtenances thereto, including traffic lights and signals.

SECTION 2. It is hereby determined and declared that said improvement is necessary to preserve the public health, welfare, safety and convenience of the Village of Madison and the residents thereof.

SECTION 3. The plans, specifications, profiles and estimates of the cost of the proposed improvement, heretofore prepared and now on file with the Fiscal Officer at the Madison Village Hall, be and the same hereby are approved.

SECTION 4. The entire cost of said improvement, less the Village's share of such costs, being not less than one-fiftieth (1/50) of the entire cost together with the cost of intersections, shall be assessed by a percentage of the tax value of all real property in the Village of Madison, Ohio, which real properties are hereby determined to be specially benefited by said improvement.

SECTION 5. The Fiscal Officer be and hereby is authorized and directed to prepare and file in her office the estimated assessments of the cost of the improvement described in this Resolution. Said estimated assessments shall be based on the estimated cost of said improvement now on file in the office of the Fiscal Officer and shall be prepared pursuant to the provision of Chapter 727 of the Ohio Revised Code and of this Resolution. When such estimated assessments have been so filed, the Fiscal Officer shall cause notice of the adoption of this Resolution and the filing of said estimated assessments to be served on the owners of all lots and lands to be assessed as provided in Section 727.14 of the Ohio Revised Code.

SECTION 6. The assessments to be levied shall be levied for the year 2025, (collected in the year 2026) payable with general taxes and collected against all real property so assessed.

SECTION 7. The remainder of the entire cost of said improvements shall be paid out of the General Fund of the Village of Madison, Ohio.

SECTION 8. No securities shall be issued in anticipation of the special assessments.

SECTION 9. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 10. This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety of the inhabitants of the Village of Madison, and for the further reason that immediate enactment is necessary in that the Village of Madison would be otherwise without funds to provide lighting for its streets; wherefore, this Resolution shall take effect and be in force immediately upon its passage and signature by the Mayor.

#### **RESOLUTION NO. 7-2025**

#### A RESOLUTION DISAPPROVING THE LAKE COUNTY 9-1-1 PROGRAM FINAL PLAN FOR THE VILLAGE OF MADISON, AND DECLARING AN EMERGENCY

WHEREAS, the Lake County Final Plan of the 9-1-1 Program governs all public safety answering points (PSAPs; also known as 9-1-1 dispatch centers) operating in Lake County, Ohio; and

WHEREAS, each county in Ohio is required to have a Final Plan and, per Ohio Revised Code § 128.06, Lake County maintains a County 9-1-1 Program Committee; and

WHEREAS, said Committee developed the Final Plan first adopted on July 1, 1988 and in 2023 additional provisions were added in anticipation of PSAPs converting to the NextGeneration 9-1-1 system (NG9-1-1) that will replace the current 9-1-1 infrastructure; and

WHEREAS, a Lake County Final Plan of the 9-1-1 Program is a state requirement, and, Ohio Revised Code § 128.08 requires each municipal corporation in the county whose territory is proposed to be included in a countywide 9-1-1 system to act by Resolution approving or disapproving the Final Plan within sixty (60) days of receipt of the plan; and

WHEREAS, the Madison Village Council has a fervent interest in providing the best services to its residents, most importantly those services related to emergency and safety, however, it finds cause for exceptions to the Final Plan which compels its disapproval.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE, STATE OF OHIO:

<u>SECTION 1</u>. That it hereby disapproves the Lake County Final Plan of the 9-1-1 Program which is on file for inspection at the office of the Fiscal Officer / Clerk of Council.

That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that, except as otherwise provided by § 121.22 of the Ohio Revised Code, all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
