ORDINANCE 9-2024

AN ORDINANCE ACCEPTING THE BID OF A&S TRUCK SALES AND SERVICE, LLC, D/B/A AUSTINBURG TRUCK CENTER, FOR THE PURCHASE OF A MACK MD642 CAB CHASSIS AND DUMP BODY; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Ordinance No. 3-2024 advertisement for bids for the purchase of a new dump truck occurred with three bids having been timely received; and

WHEREAS, upon public opening and reading of the bids on March 1, 2024, two bids were determined to be non-responsive in regard to material advertised specifications as well as delivery time; and

WHEREAS, the bid of A&S Truck Sales and Service, LLC (Ohio entity no. 4422860), d/b/a as Austinburg Truck Center, for a Mack GD642 cab chassis and dump body was the lowest and best bid at the base price of One Hundred Eight Thousand, Nine Hundred Ninety-Nine Dollars and Zero Cents (\$108,999.00 USD), plus the bid Addendum in the sum of Fifty-Three Thousand, Five Hundred Thirty-Three Dollars and Six Cents (\$53,533.06 USD), for a total bid amount of One Hundred Sixty-Two Thousand, Five Hundred Thirty-Two Dollars and Six Cents (\$162,532.06 USD); and

WHEREAS, upon recommendation of the Administration, the Council now desires to award the bid contract.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE AND STATE OF OHIO:

SECTION 1. The bid of A&S Truck Sales and Service, LLC, d/b/a as Austinburg Truck Center, for the purchase of a Mack GD642 chassis and dump body in the total sum of One Hundred Sixty-Two Thousand, Five Hundred Thirty-Two Dollars and Six Cents (\$162,532.06 USD) is hereby accepted and the Mayor is hereby authorized to enter into a contract with A&S Truck Sales and Service, LLC, d/b/a as Austinburg Truck Center, for said purchase.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety of the inhabitants of this Village and further to immediately contract in furtherance of the timely delivery of equipment necessary to the public health, safety and welfare; wherefore, this Ordinance shall take effect and be in force from and immediately upon its passage.
