PURCHASE ORDERS AND OTHER APPROVAL PERMITTED BY MOTION: None

ADMINISTRATOR'S REPORT:

> Engineer's report -

Mr. Haibach reported that he submitted an OPWC/Small Government Application to the Lake County Engineer's Office for their consideration for the Parkway Paving. The preliminary rankings came back last week, the application for funding scored very well, so he is expecting the funding for this project. Councilman Vest asked when the Wastewater Treatment Plant is abandoned, how does the process work? Mr. Haibach explained that the new pipe installed is bulkheaded, so a masonry bulkhead needs to come out. Then abandon the section of pipe that will be bypassed by the new pipe. Mr. Bailey explained that this will take place on Middle Ridge Road.

Mr. Bailey explained that there will be some work that will need to take place at the Wastewater Treatment Plant for the decommissioning however; they do not have that scope of work yet. The monies for this project will come out of the Enterprise Fund. Any leftover equipment can be sold via an internet auction, any monies made will go into the Enterprise Fund towards debt service of the water/sewer system for future debt payment.

Fiscal Officer's report –

Mrs. Crockett reported that she is working on year end, posting the final bills that have come in.

Police Chief's report –

Chief McIntosh reported that Sgt. Cudnik & Sgt. Gamiere will be attending a week-long class in Painesville through FBI LEDA which consists of three (3) different classes that are approximately 4 ½ days each. This is the first session of classes. The next sessions will be in March and May of 2024.

He reported that the new Police Charger will arrive shortly. He anticipates that after the radio is tuned and graphics are put on, it should be on the road the first week in January.

Discussion took place regarding electric/battery powered scooters. Chief McIntosh confirmed that they are not permitted to be ridden on the sidewalks and streets in the Village.

In closing, he provides a brief overview of an incident that occurred in the Parkway Estates area. Due to it being an ongoing investigation, he was not able to provide extensive comment.

Administrator's report –

Administrator Bailey reported that he is excited about the upcoming year. There are two (2) big projects coming up, one being the reconstruction on Middle Ridge Road and the second being the signalization project at I.R. 90 & S.R. 528.

He asked Council to consider what they would like to do with the water tower at I-90. It is a landmark, however; since it is not in commission, and looking weathered he thinks a plan should be in place to either remove or restore it. He stated that if it does end up coming down, it would be part of the utility transfer as an obsolete piece of equipment from the water system. Councilman Adams stated that a decision regarding the water tower will be made by the end of 2024.

He was excited to announce that he is receiving calls already from bands wanting to sing at Concerts in the Park!

COMMISSION AND COMMITTEE REPORTS:

Councilman Adams reported that at the December 20, 2023 Fire Board Meeting, they promoted two Officers, one to Lieutenant and one to Captain. There were also three (3) firefighters hired that day. He reported that Lieutenant VanKramer retired however; he and firefighter Jesse Sopko were able to walk into the station, which was very exciting! Please continue to pray for both of these men.

In closing, he reported that the work continues on Station 2. The gym is almost near completion.
