#### ADMINISTRATOR'S REPORT:

### > Engineer's report -

Mr. Lubonovic reported in Mr. Haibach's absence. He reported that in regards to the Sanitary Sewer Interconnect Project, so far Chivers Construction has removed 1,700 linear feet of pipe and four manholes. They have installed eight manholes and have installed 2,417 linear feet of 30" pipe. They currently have two crews working. The first crew has installed the second bore casing on Hubbard Road. They will be installing 30' pipe for the bore casing. The second crew is continuing work on Middle Ridge Road.

A brief discussion took place regarding the placement on the damming system.

## Fiscal Officer's report –

Administrator Bailey reported that Mrs. Crockett was supposed to be in Columbus for training, however; due to illness she was unable to make the trip.

## Police Chief's report –

Administrator Bailey reported that Chief McIntosh is out ill as well.

## Administrator's report –

Administrator Bailey reported that work is still continuing for the Concerts in the Park and the Outdoor Market.

He stated that in regards to the insurance review, he and Fiscal Officer Crockett went through the contact. He does not see a down side in making the switch. In regards to the street lights on Dayton Road, he reported that he has submitted a request however; First Energy has not gotten back to him yet.

## **COMMISSION AND COMMITTEE REPORTS:**

Councilman Vest reported that the Planning & Zoning Committee is working on a proposal that will come before Council for an Airbnb. The Airbnb's would be on State Routes within the Village and would be a Conditional Use. The Airbnb's would have to be registered and would be subject to lodging taxes.

## FINAL HEARING OF PERSONS BEFORE COUNCIL:

Ken Takacs (164 Huntington Woods Drive) – Mr. Takacs was in attendance to announce that a pact has been put together at the Board of Elections called Citizens for Madison Village Police. He stated that a bank account has been opened in this name to have a depository for funds. Mr. Takacs stated that there is a lot to be done before the primary election. He would like to have a

pancake breakfast so the residents can meet the Police Officers and let the Officers explain to them the need for a levy.

Mr. Takacs stated that he has seen over the years that Police Departments are not hiring candidates newly out of the Academy. They want a Veteran Officer, so they "steal" them from other cities. Small Communities like Madison Village cannot compete with that. He stated that going to Full Time Officers is more expensive, and then loose them to a higher paying organization, the Village is constantly training new Officers, so we have to be competitive.

He asked Council for their support, talk to friends and neighbors. Anyone who is willing to support and provide donations would be great.

He is also asking for the Police Department to recognize their responsibilities for this goal as they will be the direct recipients of the levy money.

He stated that he doesn't think that we need a door-to-door campaign. He feels that the signage campaign and the poster campaign will work. He stated that these need to get up into key areas and ask some of the businesses if they can be placed there.

Mayor Britton explained that when he met with the Department, they were instructed not to promote the levy while on duty. Mr. Takacs stated that they have a duty, when they aren't working, to help get the levy off the ground.

Mr. Takacs stated he is looking forward to hearing from Chief McIntosh and the Officers from the Department in order to get this campaign moving.

A brief discussion took place regarding inside millage.

#### **NEW BUSINESS**

## Mayor's Report: -

Mayor Britton stated that he is getting complaints regarding "jake brakes". Discussion took place regarding signage. Mayor Britton stated that if the Village does not have signs in place for this, we will get them.

In closing, Councilman Lee asked if, at the next meeting, Council could enter into executive session to discuss security at Village Hall and Council Meetings.
