## **TOURNAMENT RULES**

**1:** TOURNAMENT STRUCTURE - This is a handicapped tournament with handicap being 90% of 240. Each event will consist of 3 games. All final scores and prizes will be based on the bowlers scratch score plus handicap.

- **2:** ELIGIBILITY The tournament is open to USBC members. If you are from another association you may pay the association fees and participate in the tournament.
- 3: ENTERING AVERAGE Participants average to be used in the following order;
- (1) 2024-2025 composite average on Bowl.com.
- (2) If no 24/25 average, then 23/24 composite average will be used.
- (3) Highest current average of 21 games, as of the tournament cutoff date will be used if the bowler has no composite average.
- (4) Finally if none of the above are available, bowler will bowl scratch.
- **4:** TARDY Late bowlers must start in the frame being bowled with a zero given for the frames missed. Pacers are not permitted.
- **5:** PROPER ATTIRE Proper bowling attire shall be required to bowl, this includes no tank tops, halter tops, T-shirts with offensive material or short shorts.
- **6**: SUBSTITUTIONS All substitutions shall be made no later than 30 minutes prior to the start of the squad. The average rule will apply to all substitutes.
- 7: CHECK IN All entrants must check in for event 1 hour prior to start time
- 8: LANE ASSIGNMENTS Lane Assignments shall be made by the tournament director
- **9:** SIDE EVENTS Side events will be offered if there are enough participants.
- **10:** ENTRY REFUSAL The Martin County USBC Association reserves the right to refuse any entry
- **11:** QUESTIONS/PROTESTS The tournament director shall resolve all questions not covered by these rules. The tournament director shall reserve the right to hear and act on all protests concerning this tournament. The decision of the tournament director shall be final subject to any right to appeal under USBC Rule 329.
- **12:** RE-RATING The tournament director has the authority to re-rate any bowler prior to entry, up until the Tournament start.
- **13:** WALK-INS Walk-in entries will NOT be accepted.

You may enter team event more than once, but a minimum of 2 bowlers must be different. If bowling in multiple team events, your first team event scores will be used towards All Events.

Make check payable to the Martin County USBC Association. Full name of entrant and all required information must be shown. All entries must be printed or typed. Submit entries to any Martin County USBC Board Member or either center Stuart Bowl or Jensen Beach Bowl.
