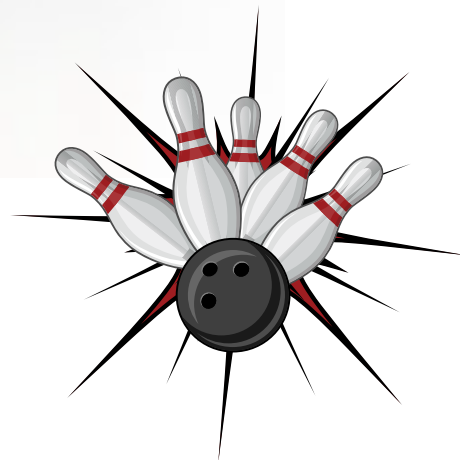
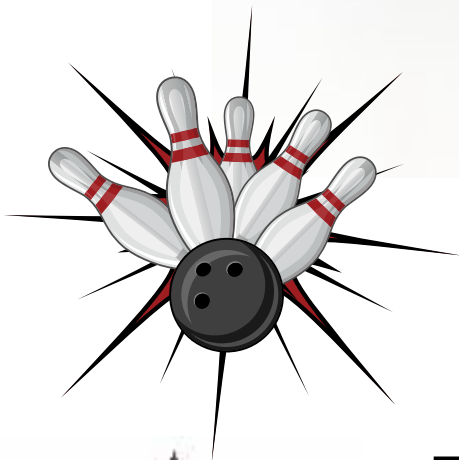

# Entry Form

1. TOURNAMENT STRUCTURE - This is a handicapped tournament open to Sanctioned USBC members. If you are sanctioned in another association, you may pay the association fee and participate in the tournament. The handicap will be 90% of 240. All final scores and prizes will be based on the bowlers scratch score plus handicap.
2. ENTERING AVERAGE - Participants average to be used in the following order;
  - ☐ 2024-25 Composite average on Bowl.com.
  - ☐ If no 2024-25 average, then 2023-24 composite average will be used.
  - ☐ Highest current average of 21 games as of the tournament cutoff date will be used if the bowler has no composite average.
  - ☐ Finally if none of the above is available, the bowler will bowl scratch.
3. TARDY – Late bowlers must start in the frame being bowled with a zero given for the frames missed. Pacers are not permitted.
4. PROPER ATTIRE – Proper bowling attire is required to bowl. This includes no tank tops, halter tops, short shorts or T-shirts with offensive language
5. CHECK IN – All bowlers must check in 1 hour prior to the start of their squad.
6. LANE ASSIGNMENTS – Lane assignments will be made by the tournament director.
7. SIDE EVENTS – Side events will be offered ..
8. ENTRY REFUSAL – The Martin County USBC Association shall reserve the right to refuse any entry.
9. QUESTIONS/PROTESTS - The tournament director shall resolve all questions not covered by these rules. The tournament director shall reserve the right to hear and act on all protests concerning this tournament. The decision of the tournament director shall be final subject to any right to appeal under USBC Rule 329.
10. RE-RATING – The tournament director has the authority to re-rate any bowler prior to entry and up to the time of the tournament start.
11. WALK-INS – Walk-ins will NOT be accepted.
