### TOURNAMENT RULES

- TOURNAMENT STRUCTURE This is a handicapped tournament. The handicap will be 90% of 230. All final scores and prizes will be based on the bowlers scratch score plus handicap.
- 2 ELIGIBILITY The tournament is open to All Martin County USBC members. If you are from another association you may pay the association fees and participate in the tournament.
- 3 ENTERING AVERAGE Participants must use their 2018-2019 highest bowl.com average for 21 games or more. If entrant does not have 2018-2019 average they may use their highest current average of 21 games or more. If entrant does not have any of the above qualifications they must bowl scratch.
- 4 TARDY Late bowlers must start in the frame being bowled with a zero given for the frames missed. Pacers are not permitted.
- 5 PROPER ATTIRE Proper bowling shall be required to bowl, this includes no tank tops, halter tops or short shorts.
- 6 SUBSTITUTIONS All substitutions shall be made no later than 30 minutes prior to the start of the squad. The average rule will apply to all substitutes.
- 7 CHECK IN All entrants must check in 1 hour prior to the start of their squad
- 8 LANE ASSIGNMENTS Lane Assignments shall be made by the tournament director.
- 9 SIDE EVENTS Side events will be offered.
- 10 ENTRY REFUSAL The Martin county USBC Association shall reserve the right to refuse any entry.
- 11 QUESTIONS/PROTESTS The tournament director shall resolve all questions not covered by these rules. The tournament director shall reserve the right to hear and act on all protests concerning this tournament. The decision of the tournament director shall be final subject to any right to appeal under USBC Rule 329.
- 12 RE-RATING The tournament director shall reserve the right to re-rate any bowler prior to entry.
- 13 WALK-INS Walk-ins are not permitted.

#### **USBC RULE CHANGE - EFFECTIVE 08/01/2019**

Rule 18 eliminates the use of any products on a bowling ball once competition has started. This includes powder, patting rosin bags on the ball, and cleaners formerly listed as approved for competition. Should a ball come back with surface residue that cannot be removed with a dry towel/cloth, bowlers must seek permission from a league or tournament official to use a product allowed to clean the ball.
