FLORIDA STATE USBC—2020 WOMEN'S TOURNAMENT RULES Team Captain: PLEASE RETAIN FOR YOUR INFORMATION

- 1) All entrants in the FS-USBC Women's Championship Tournament must be current members in their Local Association and USBC or must have a current USBC unattached membership card.
 - a) An unmarried grade or high school student who has not attained the age of 18 must furnish written consent signed by her parents or guardian. The consent shall be on a USBC approved form and shall be on file with the Tournament Director at least one week before the bowler is eligible for tournament competition unless the student is accompanied by her parent/legal guardian in which case the parental consent form may be filed up to the time the student starts to bowl.
 - b) PHYSICALLY HANDICAPPED: Handicapped bowlers requiring aids such as crutches, canes, wheelchairs, etc., or who are blind must report this in writing when entry is submitted so special schedule consideration can be arranged. Similar additional notice must be given if such a handicapped bowler is to be a substitute.
- 2) All references to average shall include averages established in USBC certified leagues and/or certified youth or collegiate leagues. Entrants in the FS-USBC Women's Championship Tournament shall use their highest certified league average as of the end of the 2018 -19 winter season, provided they have 21 games or more. If no 2018-19 winter USBC certified league average has been established, an entrant shall use her highest USBC certified 2019 summer league average of 21 games or more. If no 2018-19 winter or 2019 summer USBC certified average has been established, an entrant shall use her highest current league average for 21 GAMES OR MORE as of *April 1, 2019* (bowler must provide average verification). Bowlers who do not meet these requirements shall automatically be given a 220 average in each event in which they participate.

USBC Rule 319 DOES APPLY. All averages are subject to further verification by the Tournament Director. Tournament management reserves the right to adjust handicaps upward or downward in the event verification reveals incorrectly submitted averages.

THE ENTRANT MUST USE HER HIGHEST USBC CERTIFIED LEAGUE AVERAGE OF 21 GAMES OR MORE REGARD-LESS OF WHETHER BOWLED AS A REGULAR MEMBER OR A SUBSTITUTE. The delivery used in tournament competition must be the same as that used in establishing the entering average. All winner's averages are subject to further verification by the State Assn. Mgr.

- 3) TOURNAMENT HANDICAPPED IS 100% OF 220 WITH 1 DIVISION, OPTIONAL SCRATCH AND CHARITY EVENTS.
 - a) The State Championships are to be determined by the highest score rolled in each event, including all events.
 - b) In the event of a tie for first place in any event, co-champions will be declared. Equal awards will be given.
- 4) a) All entrants are automatically eligible for all events awards if they bowl team, doubles, and singles. To be eligible for the cash awards of the All Events an additional entry fee must accompany the entry form. Paid all events are not transferable unless the substitute replaces the original entrant in all three events and the transfer is made by the tournament director or her assistant prior to the time of the substitute's participation in any event.

- 5) Members may participate twice in the team event ONLY. At least two players in the lineup must be different in order to place more than once in the prize list for position standings. Scores bowled by an ineligible player will be disqualified. All Events standing will be determined by the bowler's first appearance in the team event counts toward their all events.
- 6) Members entered in the doubles event MUST ALSO ENTER SINGLES and members entered in singles MUST ALSO ENTER DOU-BLES event.
- 7) After entries have been received and dates assigned by the State Assn. Manager have been accepted, no fees shall be refunded.
- 8) All teams, and individuals not on teams, shall be notified in writing by the State Assn. Mgr. at least three (3) weeks before the opening of the tournament of the time they are scheduled to bowl in said tournament. No changes will be made in the entrant's scheduled time except in case of an emergency and any change must be approved by the State Assn. Mgr. or duly authorized FS-USBC official.
 - a) In all annual tournaments, the order of bowling events shall be decided by the State Assn. Mgr.

1) List the names and National ID number of the bowlers as they appear on the sanctioned card.

Team must be complete (4 bowlers), doubles (2), and singles (1 bowler) must be complete. If your entry is doubling with another entry, BOTH entries must be sent in the same envelope, so they can be processed at the same time. IF YOU HAVE A BOWLER FROM ONE ENTRY AND A BOWLER FROM ANOTHER ENTRY... list their names on one copy ONLY. Do not list any event, unless you are paying for the event on that particular entry form. The FS-USBC does not secure bowlers for teams, nor doubles/ singles. If team is not complete, or if a doubles partner is missing, the entry will be returned to sender. ADDRESSES FOR ALL MEMBERS MUST APPEAR ON THE TEAM PORTION OF THE ENTRY FORM.

- Forward the completed entry form to the Florida State USBC. If you have entered doubles/singles only, one member should sign as contact person.
- 5) AS TEAM CAPTAIN (Contact Person), YOU ARE RESPONSIBLE FOR SUBMITTING VERIFIED AVERAGES AND VERI-FIED MEMBERSHIPS (Nat'l., State & Local-see Rule #1) FOR ALL MEMBERS OF YOUR TEAM. Average and Membership printouts from bowl.com are acceptable for verification. PLEASE SUBMIT VERIFICATION WITH ENTRY. If you are waiting for an April 1, average, you should go ahead and submit your entry and be scheduled according to the scheduling polices. The April 1, average should be forwarded to the Florida State USBC office as soon as possible, so the entry processing can be completed.

Consider dates of conflicts such as Holidays, Confirmations, Graduations, etc.; after the tournament schedule has been printed there

will be no changing of dates.
