President's Report

As I prepare to write this article there are so many important issues I need to cover that I truly don't know where to start. I have just returned from a MOVEON.ORG #SAVETHEPOSTOFFICESATURDAY day of action, where there were over 30 concerned citizens rallying in front of the Main Post Office downtown to support the Postal Service. I am working closely with Lew Moyer, president emeritus, CBTU Saint Louis Chapter to organize a #SAVETHEPOSTOFFICE day of action for Tuesday, August 25, 2020. APWU Headquarters called on all of us to organize or participate in this day of action to get the word out to the senators that we need at least \$25 billion in postal funding in the next stimulus package to cover the lost revenue due to COVID-19. We need Congress to rescind the bill that they passed in 2006 to pay \$5 billion every year to fund retiree health benefits 75 years into the future. There are too many reasons to list as to why the post office needs the \$25 billion in funding, but we need it and we need it now! Our jobs depend on it. While the national election and voting rights have been combined with our efforts to secure the funding needed to make sure the Postal Service is around for decades to come, we know one thing for sure, we provide essential services to the country every day of the year, year in and year out and the public depends on us. Voters should not be forced to choose between their health and their fundamental right to vote. Voting by mail with an absentee ballot is a safe and secure method of voting in most states already. Not every voter will

choose to vote by mail, but every voter should have the option to do so and to know that if they vote by mail their ballot will be handled with the integrity and priority service that it deserves. This is a very important election and we need to make sure everyone has an opportunity to vote and to do so without worrying that their vote and voice will not be heard. The Postal Service has a 91% approval rating, making us the most trusted and valued agency in the country and PMG DeJoy is attempting to destroy that trust! We are called the United States Postal Service for a reason. PMG DeJoy is attempting to run it like a business. The services that you provide every day by coming to work to make sure that the mail is processed and delivered is vital to the country. I hope everyone is taking the time to recognize that the country is standing with us and we are not alone in this struggle. The country is finally giving you the recognition that you deserve and have deserved since the day you started working for the post office. From day one of the COVID-19 pandemic the postal employees were notified by the United States Postal Service that you were to report to work as you were considered essential workers no matter the anxiety or health concerns you had show-



ing up to work every day. United States Postal Service employees were declared essential workers because of the important **services** that you provide to the country. People in rural communities, seniors and people with disabilities depend on the USPS to deliver essential medications and daily necessities in a timely and affordable way; working people depend on the USPS for their paychecks; veterans depend on the USPS for medicines and VA benefits; small businesses depend on the USPS to ship their products to customers; and without the USPS' public service commitment to provide the "last mile" of delivery, rural and tribal communities might be excluded from mail services entirely by private companies that may not find it profitable to continue rural postal routes. People from across the country are standing up and fighting back with us! 2020 has presented some challenges like none we have ever seen, but we are the APWU; union strong and we will get through this together!

I hope everyone has received your St. Louis Gateway District Area #SAVETHEPOSTOFFICE mask. This was the executive board's way of saying thank you for your continued support and membership in the St. Louis Gateway DAL #8. If you have not yet received your mask please contact your craft director and/or the Union Hall and we will make sure it is personally delivered. If you are members of IT/ASC support services craft, please stop by the Union Hall any time Monday through Friday, 8:30 a.m. until 4:30 p.m. to pick up your masks.

Please continue to properly social distance and wear your masks. 1767s, Safety and Health forms, are being turned in every day because management and employees continue to violate postal policies regarding the wearing of masks when they are unable to maintain the proper social distancing guidelines. There have been employees put off of the clock because they refused to wear the masks. This refusal could result in Failure to Follow Instruction discipline if the request to wear the mask and to practice social distancing is not followed. If the mask is too restrictive, please notify your supervisor that you need the face shield that they are required to provide. Please remember this is for your safety as well as your co-workers. Please respect the policies. I am receiving too many reports that when the stewards walk into an area there are employees, management included, that are not practicing the guidelines. When I get those reports I go directly to the district manager. Since the start of the pandemic the Gateway District has reported over 200 COVID-19 positive cases and there have been two losses of life reported due to COVID-19. Over the last two weeks the Gateway District has averaged five COVID-19 confirmed positives a day, which means we all need to respect each other and wear the masks and social distance. The COVID-19 pandemic is still with us and we've come too far to give up now! Dignity and respect need to be applied to all aspects of our daily lives, but by following these simple guidelines it could save a life. Please stay safe and be kind to one another!

Thank you for your support and always remember, **we are all in this together.**






● Financial Crisis Threatens Postal Service

The American Postal Workers Union has always been at the forefront of racial justice. As an organization, the union has fought for all of its members and secured good paying union jobs for all. Solidarity means that we all stand together. An injustice for one is an injustice for all.

At the national convention in 2016, the American Postal Workers Union passed a resolution pertaining to the black lives movement. Two thousand delegates from around the country, all races, unanimously supported a "Black Lives Matter" resolution. It stated the APWU will encourage its members to participate in any rallies, petition drives, or other actions pursued by the campaign against racial discrimination and for transparency in policing.

In these confusing and troubling times, it is more important than ever that we pull together. We face challenges that are new and far reaching. We must not falter in our resolve to protect and keep good postal jobs.

The COVID-19 pandemic has impacted all of our lives.

Lack of child care, no school and the fear of contracting a deadly virus are very real issues. If you are not going to report to work, you are still responsible for calling in and notifying the job that you will not be present. Don't assume that since you didn't report, that management knows you are not coming. You do not want to incur AWOL charges. There is really no reason for failing to call in. Unless you are in a coma or otherwise incapacitated, you should make every effort to call in or have someone else notify the Postal Service of your situation. AWOL charges reflect poorly on your attendance and could subject you to discipline.

If you are issued discipline, make sure you file a grievance in a timely manner. You have 14 days from the date you received the discipline to file. You have to ask for a steward and do the paperwork. If you are off the clock, call the Union Hall and give the details to someone at the hall. Whatever you do, don't ignore discipline. If you have questions or need assistance, please ask your shop steward.

We will get through this.

Greetings members. In this article I would like to discuss the online check stubs that some of the members have opted to have. What I am hearing a lot of is that members who are getting their check stubs by this method are not really looking at them. Let me give you several examples of what I have heard. If you are calling off through the ERMS system (i.e. 1-877-477-3273) write down your confirmation number, and keep your confirmation numbers. Look at your 3971s when you sign them and make sure you are down for the leave you requested, this is very important because the call in can be looked up and confirmed by this number. This is going to play a big part in getting leave changed from one type to another. If you have called in for whatever reason,

please check your pay stub because if there is a problem or if you were put in for the wrong type of leave, the sooner the mistake is identified the easier it is to get fixed. Nobody wants to get ready to go on vacation and then have management tell them they can't take it because they don't have enough AL hours. Because at this point you won't be allowed to go and the union will then have to fight to get everything straightened out. There is a lot of information on your pay stubs and it's definitely not the easiest thing to read, so if you're unsure, check with someone or call me. I will help you to figure it out, even if there's nothing wrong and you just need help in understanding what you are reading. I don't know about you but I would rather be safe than sorry. As most of you know, all your

deductions are listed for that pay period and for year to date deductions. This is how you make sure that your insurance premiums are being deducted, your thrift savings is being done correctly and anything else that you are having automatically deducted from your pay is being taken out like it's suppose to be. Please, when you are looking at you pay stub take a couple extra minutes to look at the whole stub, not just what you're getting paid. This could save you from a lot of headaches later on or worse. Maloney Introduces Bill to Counter President's Politicization of the Postal Service

Rep. Carolyn Maloney, the chairwoman of the committee on oversight and reform, introduced the nonpartisan Postmaster General Act in response to President Trump's politicization of the U.S. Postal Service. Her bill comes in the wake of testimony from Postmaster General Louis DeJoy and the chairman of the Postal Service board of governors, Robert Duncan, highlighting their partisan campaign activities, extensive fundraising, and political donations of millions of dollars to GOP candidates and causes, as well as some political activities that continue even now.

The bill would prohibit the Postal Service board of governors, the postmaster general, and the deputy postmaster general from holding any political position while in office, as well as restricting nominees for postmaster general and deputy postmaster general to those who have not engaged in political activities in the four years prior to their appointments — ensuring that these positions are filled by qualified experts rather than political operatives.

“Congress passed a law in 1970 to reform the Postal Service and ensure that it is independent and removed from politics, but President Trump has turned that law on its head.” Chairwoman Maloney stated. “He installed a GOP partisan as chairman of the board of governors, who turned around and inserted his fellow Republican fundraiser as postmaster general. As we heard at our hearing, both of these officials are longtime Republican operatives, fundraisers, and mega-donors, and they are overt about their efforts to help Donald Trump win in November. In so many areas, including the Postal Service, the Census Bureau, and the Justice Department, President Trump is fundamentally degrading the long-standing independence of our core constitutional functions to his own political ends right before our eyes.”

Within hours of testifying before the committee in his role as board chairman, Duncan appeared in a prerecorded video shown at the Republican National Convention in an effort to help President Trump get re-elected. In addition, Duncan's official biography on the Postal Service's government website boasts about his fundraising prowess for partisan Republican causes: “Outside of government service, he served as chairman of the Republican National Committee from 2007 to 2009. As RNC chairman, he raised an unprec-

edented \$428 million and grew the donor base to 1.8 million — more donors than at any time in RNC history.”

Duncan is currently serving on two Republican super-PACs at the same time he is overseeing the Postal Service. American Crossroad and the Republican Senate Leadership fund.

Louis DeJoy

DeJoy, who held a fundraiser for President Trump in March of this year just prior to his selection, acknowledged that he is prolific donor to multiple Republicans.

He admitted he has donated \$3.2 million to Republican candidates and committees since 2016, including \$1.3 million to the Republican National Committee and \$1.2 million to President Trump's victory fund.

He also admitted that he was serving as chairman of the GOP fundraising committee for the Republican convention when he was chosen as postmaster general and held that position until three days before taking office.

DeJoy's admissions followed last week's revelations from former Inspector General and Board of Governors Vice President David Williams, who told members of Congress: “I resigned from the board of governors because I was convinced that its independent role had been marginalized and that representations regarding an independent Postal Service for the nation were no longer truthful. I felt the public was owed the truth in this matter.”

It also follows a warning from David Fineman, a former chairman of the Postal Service board of governors, who called the administration's interference with respect to the Postal Service “absolutely unprecedented.”

On May 15, the House of Representatives passed initial legislation (*HEROES Act*) that had provisions to fund the Postal Service. These included:

- **Emergency funding of \$25 billion** for lost revenue due to COVID-19
- **USPS access to the \$10 billion line of credit** passed in the third stimulus with no strings attached;
- **Hazard pay** for postal and other essential front-line workers
