### Introduction

Albemarle Land & Timber Services, Inc., is pleased to offer for sale the following tract of land and its improvements. This is a nice parcel of land consisting of reforested acreage replanted in the spring of 2021 along with cultivated fields with an abundance of road frontage on Pender Road. This parcel has woodland behind the fields with separate access off Pender Road with a metal gate. This parcel offers a good location to local stores and a great place to build a house, or several houses, with plenty of recreational or a working farm producing income attached.

### Location and Description

The property line trees are painted and have been left to still be able to identify the property boundary lines in the wooded area. The majority of the wooded acreage was replanted by hand crews with Hybrid Loblolly Pine Seedlings on a spacing grid of 8 ft by 10 ft equating to approx.. 545 trees to the acre. There is a small area of natural Loblolly Pines growing back in the middle of the tract which are approx.. 10 years old surrounded by the 4 year planted stock.

There are abundant White Tail Deer, Wild Turkey and an occasional Black Bear in this area. Distance to local restaurants, grocery stores and the nice town of Hertford are only a short drive. Most of this tract is upland cultivated ground currently being farmed for cash crops such as Corn, Soybean, Wheat, and Cotton and the woods with Hybrid Loblolly Pine.
