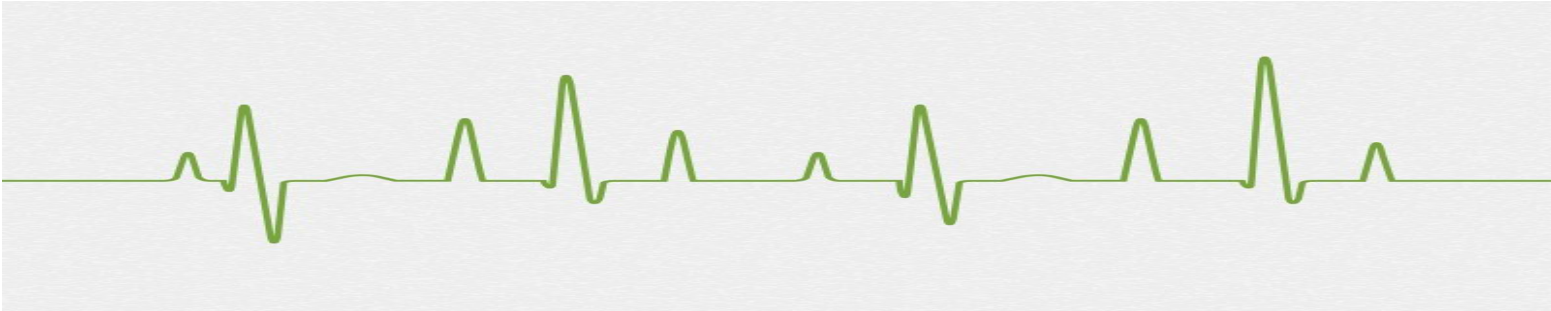




Grove Club

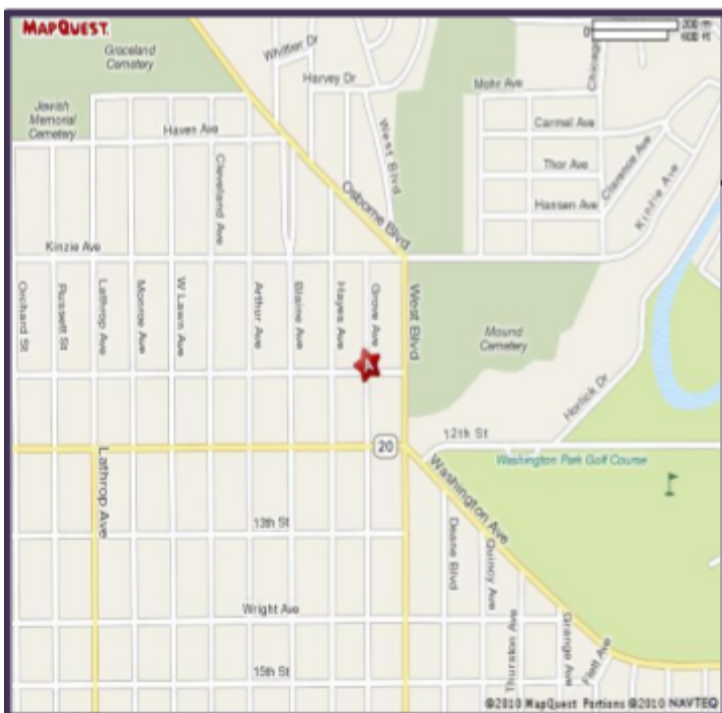
