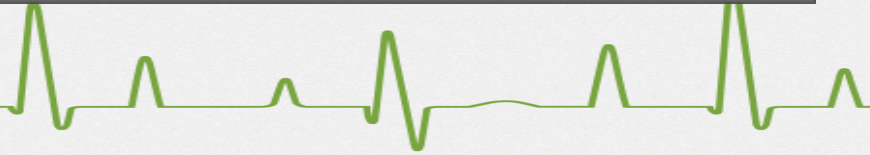


# Grove Club

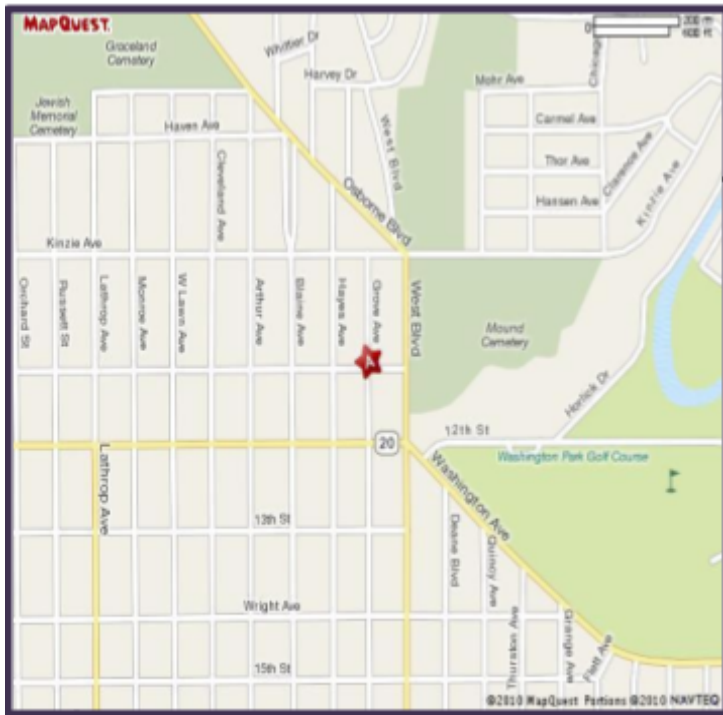
