GENERAL

Your legal status is that of a guest. There is no Landlord/Tenant Agreement between guests and the Owner(s)/Management. You are being provided services under this Agreement and theft of services applies pursuant to all applicable laws of the State of Texas. We do not discriminate based on race, sex, religion, nationality, disability, age, veteran's status, or any other classification protected by law. You, as a guest of Stay Awhile RV Park & Farm, determine if the property is adequate and safe for you and your visitors. You will be responsible for any actions of your visitors and any violations they may perform. Occupancy at your site is limited to the names on the Guest Application. You agree that you have reviewed Stay Awhile RV Park & Farm and the site you are renting and are satisfied that the property and grounds meet your needs, including accessibility. You agree that your RV will not be vacant unless you have notified Management of your intent to be off-premises and the number of days you will be gone. Long-term vacancies are not permitted. You may not assign or sublet your site. In exchange for rights granted herein, you agree to defend, indemnify, and hold harmless Stay Awhile RV Park & Farm, its officers, directors, employees, and agents from and against any and all losses, claims, damages, costs and expenses (including reasonable legal fees) that Stay Awhile RV Park & Farm may incur arising or resulting from your use of the site. Stay Awhile RV Park & Farm Owner(s)/Management will not be responsible for accidental injury or death, or loss of property by weather, fire, vandalism, theft, wind, or any other acts of God. You agree that your RV is adequately covered for physical loss either by personal financial responsibility or a purchased insurance policy that insures against any physical loss. Any vehicle brought onto the premises of Stay Awhile RV Park & Farm must be properly licensed, registered and covered by liability insurance as required by the State of Texas. RV's that are older than 10 years from the date of move-in must be pre-approved by Management, to maintain a certain standard, we have a limitation on RV appearance and accept all well-maintained RV's only and do so at our sole discretion. No modification to RV's (including paint schemes) beyond what the manufacturer has installed are allowed.

RENTAL

Rental rates are daily, weekly, monthly and are published at our premises office as well as on our park website. Prices are subject to change from time to time and will be published. All guests, whether daily, weekly, or monthly agree that vacating your site early will NOT constitute a refund or any prepaid rent or applicable fees. For our monthly guests, if moving in after the 1st, your first month will be prorated. All payments due prior to move-in. Monthly rent is due on the 1st of each month and a late fee of \$35 will be charged if received after the 3rd day. An additional \$10 per day will be charged until paid in full. Stay Awhile RV Park & Farm may terminate this Agreement at its sole discretion by providing written notice to vacate the site as allowed by Texas Law if you or your visitor(s) violate the rental terms or any of the Rules and Regulations of our park. Additionally, Stay Awhile RV Park & Farm can issue a 72-hour eviction notice if a guest is in default of this Agreement.

CONNECTIONS

Water and Sewer connections must be tight and lead-free at all times. A sewer hose "donut" or "L" connector is required and sewer lines must maintain a proper slope for drainage. Absolutely no "dips" in sewer hoses are allowed. All sewer lines must be up off the ground. Management will notify you if your sewer hose is in violation and must immediately remedy the problem to be in compliance with all EPA regulations and applicable Texas codes. Stay Awhile RV Park & Farm will provide for the winterization of water pipes up to the connecting spigot. We encourage guests to winterize your water line from the supply to your RV connection. If a water leak is observed on the "guest" side of the water supply, water will be turned off by management until the leak is repaired. Leaks do happen from time to time on either side and by working together we can resolve these problems as quickly as possible. Water pressure sometimes varies and can exceed the capabilities of your RV, you may purchase a water pressure regulator at any supply store. Electrical connection to our pedestal must be appropriate for the power usage intended. No adapters without prior permission. No corroded or exposed wires will be allowed. Stay Awhile RV Park & Farm does not perform any electrical repair to your RV. You are responsible for any damage to our pedestal.

Wi-Fi INTERNET

Basic Wi-Fi internet is provided free for our park guests. Contact the office for the current password.

VEHICLES

PLEASE OBEY ALL POSTED SPEED LIMIT SIGNS! The speed limit throughout Stay Awhile RV Park & Farm is **10 mph! This is STRICTLY ENFORCED** for the safety of our guests. ALL guest entries to the park will STOP at Stop sign. A few sites will accommodate more than one vehicle. One vehicle can be parked at tongue of RV and one can be parked at back. No vehicle should be parked on the side of the RV. There is also extra parking available on the side of the office. If you have a 2nd vehicle, small tow car, motorcycle, or scooter, you may park it inside your designated parking area if it will fit completely inside your site's parking space. Golf carts are allowed but must be parked within your site area when not in use. No parking is allowed in roadways, on grass or on vacant sites. Working on vehicles is not permitted. You may wash your RV as needed but please limit water use. Storage of vehicles is prohibited as well as open/enclosed trailers, tow dollies, utility trailers or boats. We do not allow the use of 4-wheelers or dirt bikes. On-site storage lots are available for a monthly fee. (See Park office for details). All vehicles must be properly licensed, insured and registered per state laws. No abandoned or inoperable vehicles are allowed.

RV SITE AREA

RV site areas are required to be kept neat and free from unsightly clutter. Foil on windows and window units are not permitted. Items stored outdoors are to be kept to a minimum and to those items that are designed for RV living. Any steps, landings, and storage buildings that are constructed need prior approval. Approval requests must be in writing. Extra rooms or tarped extension areas cannot be installed. Only "slides" that are manufactured on the RV are allowed. Absolutely no tarps on or around your RV are permitted unless there is a need to temporarily cover in case of a water leak. All tarps must be approved & the leak must be repaired in 3 days and tarp removed. Gardening is limited to 2-4 small flowerpots. Please do not install flower beds, gardens, border materials or items that will "scar" the ground without written permission. Please do not nail or attach items to trees or shrubs.. No clothes lines or outdoor laundry is permitted at any time. Please use the on-site laundry facility. Please consult management for any yard carpet for your site. You may have outside trash cans with lids at your site. We offer trash pick-up service 3 times per week on Monday, Wednesday & Friday for those that have the proper trash receptacles and tied garbage bags. Please remember this is a free service that we provide for our guests, and we will not pick up any trash that is not properly bagged. If you choose, you may discard your own trash in one of our available dumpsters. If trash from your RV site is strewn throughout the park due to not being bagged and placed in properly covered receptacle, a trash receptacle will be placed on your site and your account will be charged \$25 plus tax. No advertising or soliciting at RV site. You can submit advertisements to the office for approval & then posted to Community Board.

SMOKING & ALCOHOL

Cigarette butts and their disposal are **STRICTLY ENFORCED**. If you smoke, please extinguish your butts and dispose of them at your site in your own receptacle and **NOT** on the ground. Please take extra care to see that butts are extinguished completely before discarding. No smoking inside office, laundry, or restroom facility! Alcoholic beverages are to be kept strictly at your site area. When outdoors, please use a cup or Koozi. **NO EXCEPTIONS**. No alcoholic beverages allowed in office, laundry, or restroom facility per Texas State laws. Drunkenness and disorderly or abusive conduct will **NOT** be tolerated, and eviction may occur. Any belligerence will be handled individually and may include law enforcement at the discretion of management.

CHILDREN

Parents and Guardians are responsible for the actions of their children, including destruction of property whether owned by the park or other paying guests. Instruct your children to refrain from entering other guest's sites or crossing between RV sites and vehicles. Please **DO NOT** allow your children to play in any areas that are undergoing construction or renovation. Do not allow children to play on or around any construction equipment. Please obey all warning signs. Children must always be supervised by an adult at the park. **USE AT YOUR OWN RISK**. No wheels on the sidewalks please. (Skateboards, bikes, scooters, etc.).

PET POLICY

Stay Awhile RV Park & Farm allows pets, but we have certain restrictions. Prior to pets' arrival, guest is required to submit a copy of vaccine records to the office. Your pet(s) must always be kept on a leash while outside your RV and you must remain with your pet when exercising it. No outside pens, cages or doghouses are allowed. Pets may "go freely" in the provided Dog Runs that are available in the park. **PLEASE CLEAN UP** after your pet. There will be a \$25 per incident fine if caught not picking up after your pet(s) to be paid before leaving the park or when your next rent payment is due. Management reserves this right and will make the final decision should there be any question regarding certain pets.

RECEIVING MAIL

If you wish to have mail or packages sent to the RV park, use this address: 10101 State Hwy. 31 E. Murchison, Tx. 75778. USPS, UPS and FedEx will deliver here at the office. As a reminder, the office is open Monday – Friday 9am – 5pm, Saturday 9am – 12pm by phone and is closed on Sundays. All mail/packages will be out by 4pm daily, Saturday's mail will be put out on Monday, providing postal carrier has delivered by that time.

CONDUCT

Quiet hours are from 10pm to 10am daily. Loud and disorderly conduct will not be tolerated at any hour and could be cause for eviction. Music and Media is to be kept at a level as to not disrupt your neighbors or their guests, especially between Quiet hours. Complaints regarding this type of violation are strictly enforced. Be considerate of your neighbors!

FIRES

Fires in approved manufactured metal pits/rings ONLY. No rocks, bricks, flashing or sheet metal allowed. No leaf or pine needle burning. Sticks of wood are available for purchase at the office.

FISHING

Fishing allowed with **NO** license required. Pond for use of residents and registered guests ONLY. ALL INJURED fish must be kept! No motors above trolling motor Hp OR for paddle boats, kayaks, canoes or flat bottoms. All **Brim** can be kept, no limit!! All others must be as follows: Catfish over 12 inches, Crappie over 10 inches and Bass 2-5 pounds. **NO SWIMMING!!!! NO** driving any type of vehicle in or around pond area without Management permission. NO EXCEPTIONS.
