



WAIVER AND RELEASE OF LIABILITY

IN CONSIDERATION OF the risk of injury that exists while participating ON THE TRAILS or ANY OTHER ACTIVITIES WHILE ONSITE (hereinafter the "Activity"); and

IN CONSIDERATION OF my desire to participate in said Activity and being given the right to participate in same;

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively, "Releasor," "I" or "me", which terms shall also include Releasor's parents or guardian if Releasor is under 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and

I HEREBY release and forever discharge ISLAND OFF-ROAD, LLC, located at 2858 N Dixie Hwy, Boca Raton, Florida 33431, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors, and assigns (collectively "Releasees"), from any physical or psychological injury that I may suffer as a direct result of my participation in the aforementioned Activity.

In the event that any damage to equipment or facilities occurs as a result of my or my family's or my agent's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such actions of neglect or

recklessness.

I acknowledge that my participation in trail riding, mud pit, and camping activities entails known and unanlicipated risks that could

result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks

simply cannot be climinated without jeopardizing the essential qualitics of the activity.

The risks include, among other things: the possibility of rough terrain, slips and falls; passengers can be jolted, jarred, bounced around,

thrown about and otherwise shaken during rides; collision with fixed or movable objects, or vehicles; hypothermia, hyperthermia (heat

related illnesses), heat exhaustion, sunburn, dehydration; exposure to potentially dangerous wild animals, insect bites, and hazardous plant

life: aggressive and/or poisonous marine life; sprains, strains, scratches, bruises, abrasions, cuts, lacerations, broken bones, fractures,

musculoskeletal injuries including head, neck, and back injuries; wrist, arm, or shoulder injuries; equipment failure and/or operator error;

the negligence of other visitors, participants, or other persons who may be present; improper lifting or carrying; my own physical

condition, and the physical exertion associated with this activity; transmissible pathogen or disease; traveling to and from activity
