Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$30.00. You may register your dog online at <http://nasda.dog/registration/>.

Rules:

- All hides are blind for Level 3 and above. There is only one set up per course. Handlers may use additional handlers for subsequent dogs

Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying scores, high in class (3 or more dogs). New title ribbons will be awarded.

Venue:

Kirkwood Mountain Resort is an operating ski resort and has a base altitude of 7,800 ft. Be sure to give yourself and your dogs time to acclimate to the higher elevation. Trialing areas will not be fenced, and wildlife and other natural distractors may be present. Please be respectful of the resort and other guests/residents, including watching noise levels and cleaning up after ourselves.

Exhibitors will be crating in their vehicles in the parking lot. **Trailed by 20 Hounds** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack shade or blankets, food, water, and anything needed to keep you and your dog comfortable. **Event will be held rain, snow, or shine.**

Lodging: Lodging at Kirkwood may be booked directly through the resort or on any accommodation website. Since it is the off season restaurant and dining options in Kirkwood will be closed in the evenings. There are also many hotel and camping options in nearby in South Lake Tahoe, where restaurant and dining options will be abundant.

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- Final Confirmation emails will be sent at least 48 hours before the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.

- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Exhibitors with 3 or more dogs entered in a level two or one class will be required to run at a specific time assigned by the club or will need to provide additional handlers for subsequent dogs, at the club's discretion. You will be notified at time of entry if an additional handler will be required.
- Bitches in Season may compete in the event. The Trial Secretary must be notified in advance. BIS will run last in their class, and the panties must be worn when the dog is outside of vehicle except to potty.
- Move ups from trial to trial and day to day are allowed. A move up form must be completed for day to day move ups. Trial Secretary and Judge must be notified in advance for trial to trial move ups.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **20 Hounds**.
- **Trailed by 20 Hounds** reserves the right to refuse any entry without cause or explanation.
