Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25.00. You may register your dog online at <http://nasda.dog/registration/>.

Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying scores, best in breed (2 or more dogs), and high in class (3 or more dogs). New title ribbons will be awarded.

Venue:

Exhibitors will be crating in their vehicles. **Trailed by 20 Hounds** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack shade, food and water for you and your dog.

Overnight Stay Information:

On-site dry camping is available (\$30 a night for tent or car, \$60 a night for RV)

Hotel options include: La Quinta, Ayres Hotel, Motel 6, Extended Stay, Hampton Inn

Note: There is an agility trial on the same grounds this weekend so book early

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Bitches in Season may compete in the event. The Trial Secretary must be notified in advance. BIS will run last in their class, and the panties must be worn when the dog is outside of vehicle except to potty.
- Move ups from trial to trial and day to day are allowed. A move up form must be completed for day to day move ups. Trial Secretary and Judge must be notified in advance for trial to trial move ups.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **20 Hounds**.
- **Trailed by 20 Hounds** reserves the right to refuse any entry without cause or explanation.
