Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25.00. You may register your dog online at <http://nasda.dog/registration/>.

Urban & Lost Item Challenge Rules:

- All hides are blind.
- There is only one set up per course.
- Handlers may use additional handlers for subsequent dogs.
- Searches are designed to test skills, not endurance.
- There are no Best of Breed points.
- First thru Tenth place points and ribbons awarded if 3 or more dogs compete in a class.

Awards:

Awards will be handed out at the conclusion of the trial. Regular class ribbons are awarded for qualifying scores and high in class (3 or more dogs). Urban & Lost Item challenge ribbons are awarded for qualifying scores and 1st thru 10th place. New title ribbons will be awarded.

Venue:

These are private residences. Properties used are adjacent to each other. Livestock and other natural distractors will be present on site. Please be respectful of neighbors, including watching noise levels and cleaning up after ourselves. Exhibitors will be crating in their vehicles, in order to maximize space please park perpendicular to the property's fence-line. **Trailed by 20 Hounds** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack shade or blankets, food, water, and anything needed to keep you and your dog comfortable. **Event will be held rain or shine.**

Trailed By 20 Hounds will be hosting a Thanksgiving Dinner on 11/27/2025 on site for all exhibitors, club members, and their family members that wish to attend. Please RSVP by 11/19/2025.

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- Final Confirmation emails will be sent at least 48 hours before the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Bitches in Season may compete in the event. The Trial Secretary must be notified in advance. BIS will run last in their class, and the panties must be worn when the dog is outside of vehicle except to potty.
- Move ups from trial to trial and day to day are allowed. A move up form must be completed for day to day move ups. Trial Secretary and Judge must be notified in advance for trial to trial move ups.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **20 Hounds**.
- **Trailed by 20 Hounds** reserves the right to refuse any entry without cause or explanation.
