

# Anomaly LARP Waiver / Consent to Play



I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN THIS EVENT AND FUTURE EVENTS I CHOOSE TO ATTEND HELD BY Anomaly LARP. I certify that I am physically fit, sufficiently prepared for participation in the event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this Event. In consideration of permitting me to participate in this Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (a) I WAIVE, RELEASE, AND DISCHARGE Anomaly LARP, a non-profit corporation, and its officers, directors, board members, employees and agents (collectively Anomaly LARP), from any and all liability, including but not limited to, liability arising from the negligence or fault of Anomaly LARP, for my personal injury, death or disability, property damage, property theft, or actions of any kind which may hereafter occur to me while participating in this Event. (B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE Anomaly LARP from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of Anomaly LARP, or one of its sponsor partners or otherwise. I acknowledge that Anomaly LARP is not responsible for the errors, omissions, acts, or failures to act of any party or entity conducting the Event on behalf of Anomaly LARP. (C) I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this Event. This waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

By agreeing to play this game I grant limited consent to roleplaying within a challenging environment, including but not limited to villainy, violence, weapons, all things described or inferred in the Anomaly Official Rulebook and on the anomaly.com website, experience of loss, death, the unknown, difficult ethical choices, and threat of all of the above. If I think or feel the game is going in a direction I do not wish to participate in, I acknowledge I may at any time use the safety rules of the game to modify or exit that scene.
