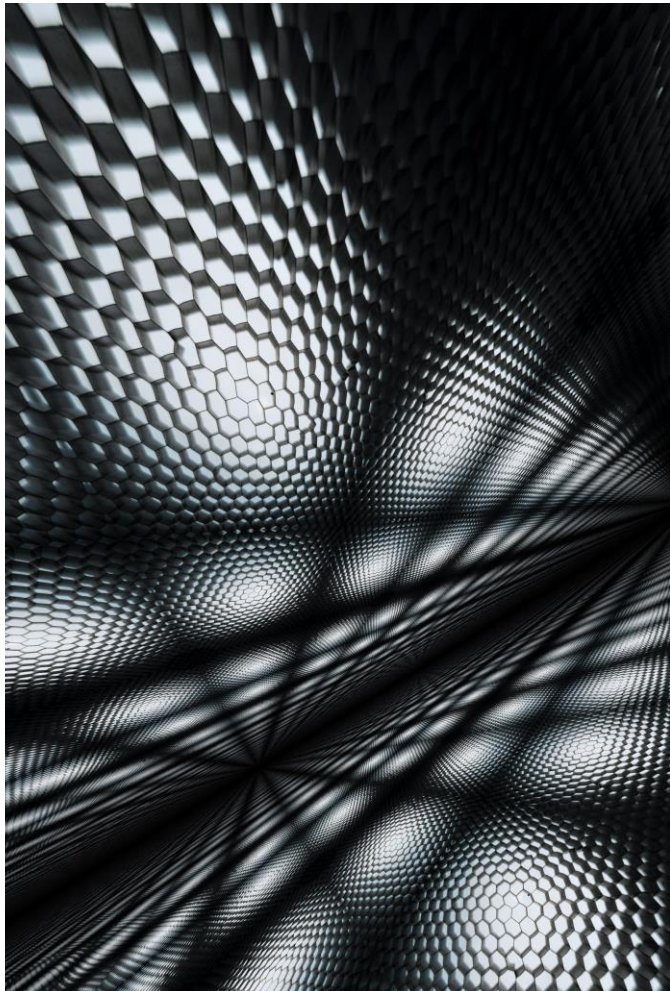
INTEGRATIONS DONE RIGHT

When InsightForms was launched in 2019 we quickly realized this service filled a need for our clients. InsightForms enables offline data capture for required documentation. Forms can be completed on any mobile device or from a web browser. InsightForms eliminates many DOT required paper documents and automatically migrates the electronic documents back to the employees profile within BeaconInsight in real time. With built-in criteria controls, most forms submitted via InsightForms no longer need human verification.....saving time and administrative oversight.

SECURITY IS PARAMOUNT

SOC II CERTIFICATION

SOC 2 or System and Organization Controls 2, is a set of criteria developed by the American Institute of CPAs (AICPA). The SOC 2 criteria is specifically designed for service providers managing customer data and is based on five "trust service principles." security, availability, confidentiality, processing integrity and privacy. Most SOC 2 certifications cover a 12-month period, which means BeaconInsight will be audited every year to ensure we meet the criteria. BeaconInsight maintained SOC 2 certification in 2020.

SECURITY NOTICES

In December 2020, a global intrusion campaign was discovered utilizing a supply chain attack via SolarWinds Orion business software updates intending to distribute malware referred to as SunBurst. This campaign was widespread impacting both public and private entities around the world. BeaconInsight has never used SolarWinds products for any of its systems. We conducted a vendor analysis of all third-party products and solutions that may have affected our customers' data (including but not limited to our cloud hosting environment, email systems, backup solutions and enterprise networks) and concluded that none of them were impacted. Out of an abundance of caution, we performed additional security audits and scans of all our production servers and found no trace of the SolarWind intrusion or any other evidence that our customers' data has been compromised.
