Seller accepts no liability for any communicable diseases after 72 hours from when the puppy leaves the possession of the seller. If the puppy does not pass a general health exam buyer agrees to notify the seller within 24 hours of the exam with a copy of the original signed license veterinary statement. Health guarantee does not cover any parasite internal or external as these are treatable. Puppy will be returned to seller at the buyers expense and examined by the sellers veterinarian. If the seller's veterinarian is in agreement with the buyer's veterinarian a full refund will be given.

6. SPAY/NEUTER

If purchased as pet only the buyer agrees to not use this puppy for breeding and to have the puppy spayed or neutered at the age recommended by their veterinarian

7. SHIPPING

All shipping costs including health certificate will be the responsibility of the buyer. The seller will not be held responsible for any death or injury to the puppy due to the negligence of the airline or live animal carrier
